S 88° 55' 52" W (694.64) feet from a stone (found) at the
Northeast corner of a (20) acre parcel as recorded in Deed
Book 763, Page 277, passing an iron pin (set) at (47.36)
feet from the West line of said Lot #4; thence S 1° 19' 17" E
(1,292.19) feet to an iron pin (set) on the South line of
said Lot #4; thence along the South line of said Lot #4
S 90° 00' 00" W (1,980.00) feet to the place of beginning,
passing South of a stone (found) at (694.64) feet, through
a stone (found) at (942.26) feet, through an iron pipe
(found) at (1,815.00) feet, South of a stone (found) at
(1,815.00), containing (58.677) acres.

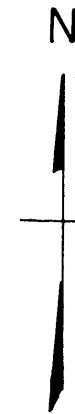

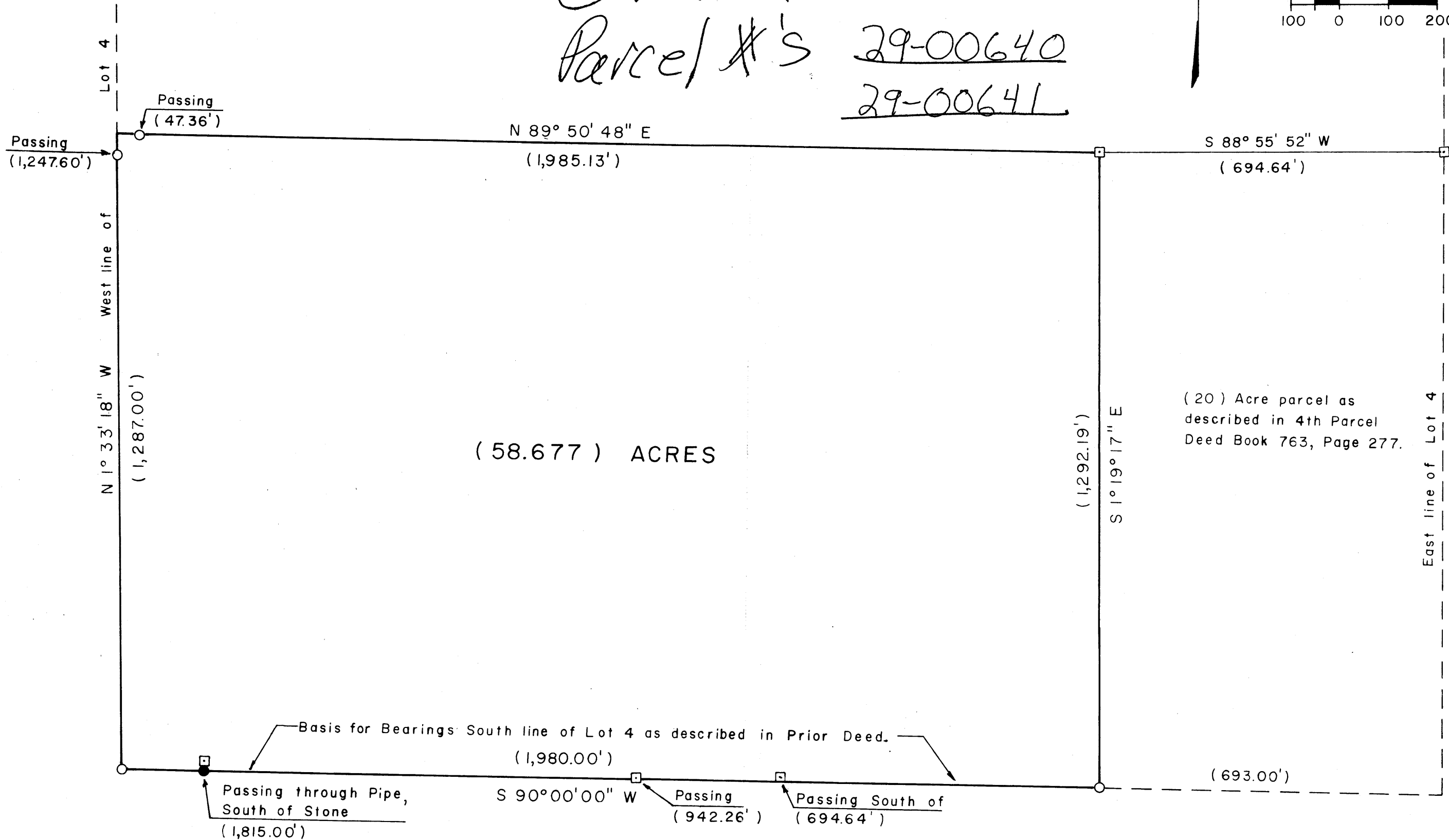
SURVEY PLAT FOR DAMIAN WISE PROPERTY
