

**SURVEY DESCRIPTION
FOR

ALL OF AUDITORS PARCEL
29-20-61-02-000 (2.22 Acres)



Situated in School House Lot 13, Quarter Township 1, T-3-N, R-1-W, U.S.M.L., Jackson Township, Muskingum County, Ohio.

Beginning at the intersection of Scout Road, Clay Pit Road and Mt. Zion Road, said point is recorded as being located from the Southeast corner of School House Lot 13, the following 2 courses, Commencing at the Southeast corner of lot 13; thence, N.84°06'47"W. a distance of 435.99 feet along the South line of lot 13 to a point in the center of Scout Road; thence, N.22°28'39"W. a distance of 1,335.14 feet to the above stated point of beginning;

Thence, S.69°43'35"W. a distance of 191.06 feet along the center line of Clay Pit Road to a point;

Thence, S.78°30'08"W. a distance of 96.70 feet along the center line of Clay Pit Road to a point;

Thence, N.81°38'35"W. a distance of 53.23 feet along the center line of Clay Pit Road to a point;

Thence, N.75°14'15"W. a distance of 50.77 feet along the center line of Clay Pit Road to a point;

Thence, N.06°06'04"W. a distance of 126.24 feet along the lands, now or formerly, owned by M. Wisecarver (1514/291) to a found iron pin, passing a found iron pin at 22.93';

Thence, N.87°59'14"E. a distance of 204.96 feet along said Wisecarver lands to a found iron pin;

Thence, N.05°58'55"W. a distance of 435.70 feet along said Wisecarver lands to a found iron pin on the South line of the lands, now or formerly, owned by the Bowerston Shale Co. (428/360);

Thence, N.85°55'35"E. a distance of 67.80 feet along said Shale Co. lands to a point in the center of Scout Road, passing a found iron pin at 67.80';


Thence, S.12°35'41"E. a distance of 297.56 feet along the center of Scout Road to a point;

Thence, S.15°44'33"E. a distance of 98.05 feet along the center of Scout Road to a point;

Thence, S.22°26'09"E. a distance of 132.76 feet along the center of Scout Road to a the point of beginning.

The above described parcel contains 2.22 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.


