Myers ( deceased ) and Betty Louise Myers in Deed Book 618, Page 245, Deed Book 461, Page 200, Deed Book 508, Page 893 and Deed Book 551, Page 358 of the Muskingum County Deed Records bounded and described as follows:

Beginning at an iron pin found at the corner common to Lots 13,14,17 and 18; thence south 87 degrees 10 minutes 55 seconds east along the north line of said Lot 18 and the south line of property owned by Bowerston Shale Co.,Inc. ( Vol.514, Pg.239 ) a distance of 297.66 feet to an iron pin set ( the base of bearing for this description being state plane grid from solar observation); thence south 2 degrees 31 minutes 42 seconds west along the west line of property owned by Daniel Osborn ( Vol.630, Pg. 222 ) a distance of 1767.38 feet to an iron pin set; thence north 87 degrees 10 minutes 54 seconds west along the north line of a 4.49 acre parcel owned by Foster and Mable Wolford a distance of 297.66 feet to an iron pin set on the Lot line between said Lot 18 and Lot 17;thence north 2 degrees 31 minutes 42 seconds east along said Lot line and the east line of a 30.00 acre parcel owned by Wayne and Emily Levering ( Vol.766, Pg. 244 ) a distance of 130.00 feet to an iron pin set; thence north 85 degrees 38 minutes 57 seconds west along the north line of said Levering 1352.98 feet to an iron pin set; thence north 3 degrees 09 minutes 25 seconds east along the east line of property owned by Elisha and Olive Adkins ( Vol. 782, Pg. 165 ) , Rebecca Sterling ( Vol. 773, Pg. 305 ) and Nellie L.Addis ( Vol. 1027, Pg. 569 ) a distance of 1637.33 feet to an iron pin set on the north line of said Lot 17 and passing through an iron pin found at the northeast corner of said Sterling parcel at 536.24 feet and passing through an iron pin set in the center of the access drive to the property being described herein at 1172.44 feet; thence south 85 degrees 37 minutes 51 seconds east along the north line of said Lot 17 and the south line of property owned by Gregory and Melinda Babcock ( Vol. 996, Page 94 ) a distance of 1335.02 feet to the place of beginning containing sixty two and five hundred seventy seven thousandths ( 62.577 ) acres more or less of which 12.077 acres is in Lot 18 and 50.500 acres is in Lot 17.

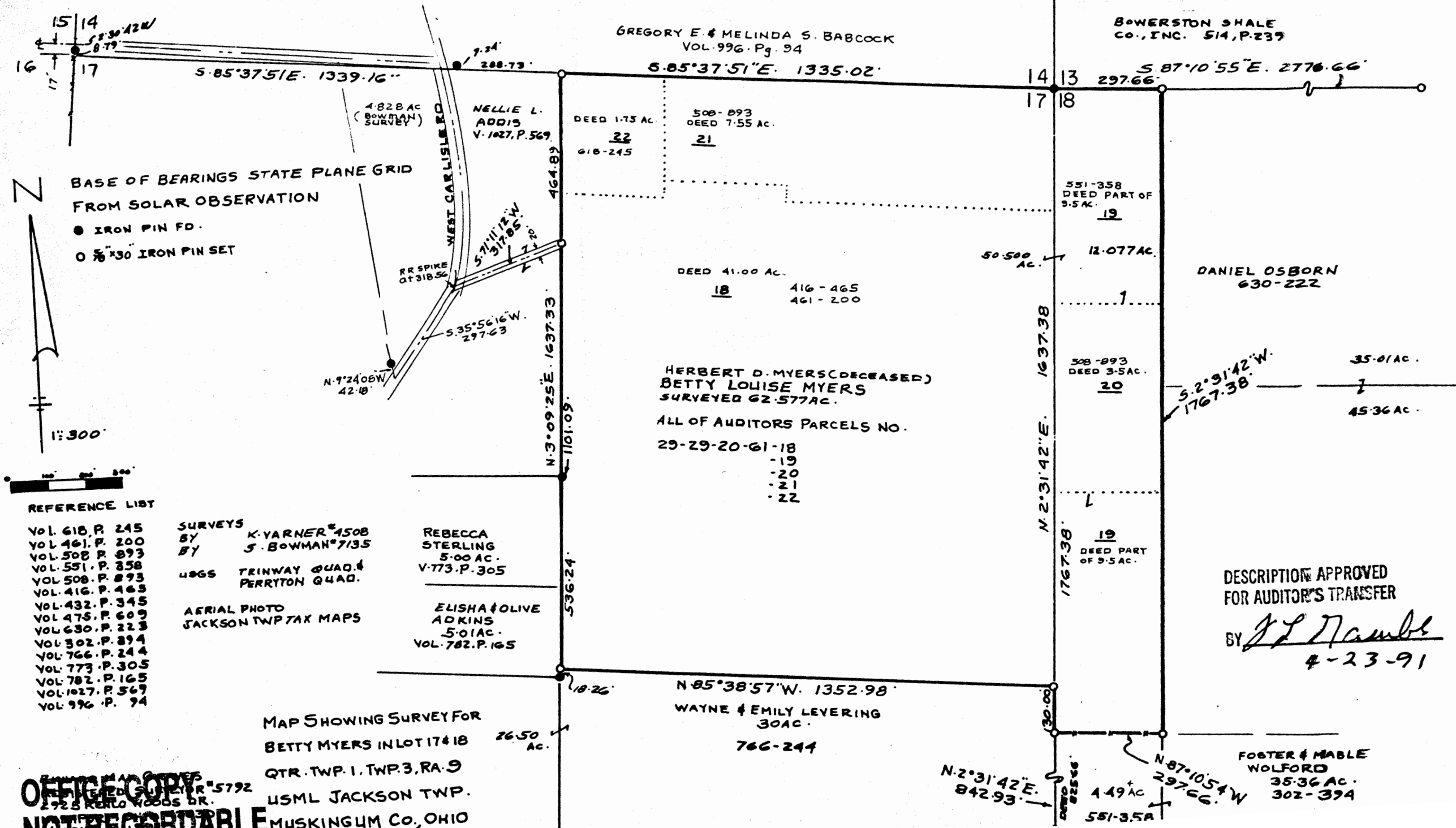
