Situated in Jackson Township, Muskingum County, State of Ohio and being a part of Section 15, Second Quarter, Township 3 North, Range 9 West, United States Military Lands, more fully described as follows:

Beginning for a point of reference at the Northwest corner of the Northeast Quarter of Section 15 and marked by a found iron pin;

thence N 89° 22' 27" E along the North line of said Northeast Quarter a distance of 653.57 feet to the True Point of Beginning of the herein described tract and marked by a set iron pin, passing a set iron pin at 86.29 feet;

thence continuing N 89° 22' 27" E along said North line a distance of 324.95 feet to a point marked by a set iron pin;

thence S 0° 26' 59" E a distance of 1230.54 feet to a point on the center line of O'Dell Road, passing set iron pins at 768.00 feet and 1200.54 feet;

thence S 65° 58' 13" W along the center line of O'Dell Road a distance of 354.55 feet to a point;

thence N 0° 26' 59" W a distance of 1371.38 feet to the True Point of Beginning, passing found iron pins at 30.00 feet and 536.38 feet;

Containing 9.705 acres.

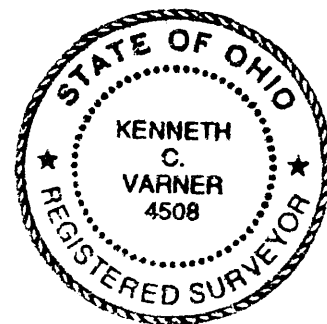
