

DESCRIPTION

Situated in Jackson Township, Muskingum County, State of Ohio and being a part of Section 15, Second Quarter, Township 3 North, Range 9 West, United States Military Lands, more fully described as follows:

Beginning at the Southwest corner of the Northeast Quarter of Section 15 and marked by a found iron pin;

thence S 89° 54' 37" E along the Southerly line of the Northeast Quarter of Section 15 a distance of 750.68 feet to a point marked by a set iron pin and being the True Point of Beginning of the herein described tract;

thence N 0° 33' 05" W a distance of 1331.42 feet to a point on the center line of O'Dell Road, passing set iron pins at 570.00 feet and 1301.42 feet;

thence N 65° 58' 13" E along the center line of O'Dell Road a distance of 648.80 feet to a point marking the Northeast corner of subject title lands;

thence S 0° 33' 05" E along the Easterly line of subject title lands a distance of 1596.57 feet to a point marked by a found iron pin and being the Southeast corner of subject title lands, passing a found iron pin at 20.00 feet;

thence N 89° 54' 37" W along the Southerly line of the Northeast Quarter of Section 15 a distance of 595.12 feet to the True Point of Beginning.

Containing 20.00 acres as surveyed by Kenneth C. Varner, Reg. Surveyor No. 4508 in June 2004.

Subject to all valid and existing building and other restrictions and conditions of record, to all valid and existing zoning laws, ordinances and resolutions, to all valid and existing easements of record.

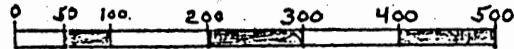

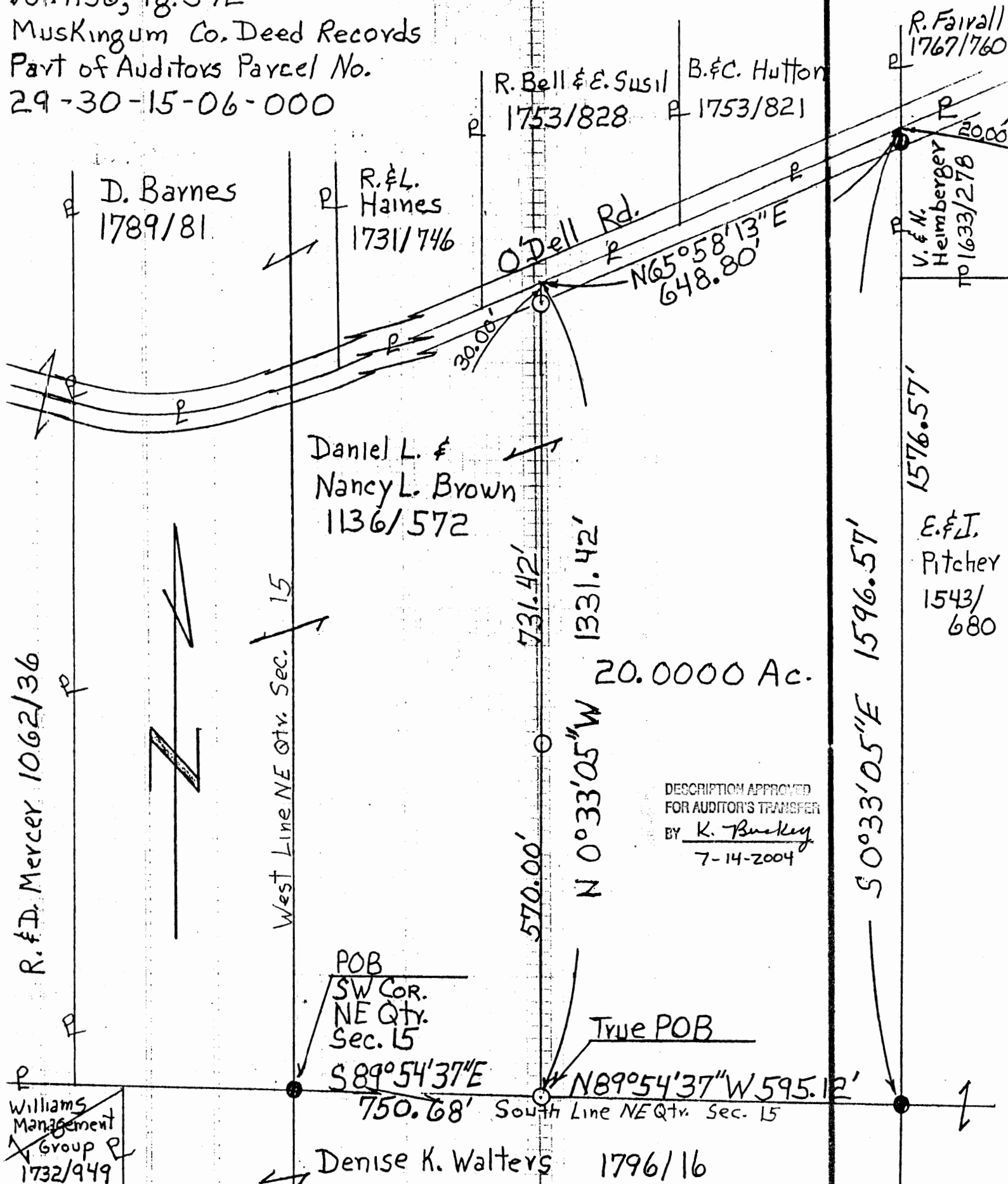
