

DESCRIPTION OF SURVEY FOR HELENE RANDALL

Situated in the State of Ohio, County of Muskingum, Township of Jackson:

Being part of the Northwest Quarter, of Section #16, Township #3, Range #9, of the US Military District, further being part of the George Randall property described in deed reference Deed Book Volume 442, Page 261 of said county's deed records, further **being part of Muskingum County Auditor's Parcel Number 29-30-16-09-000**, and more particularly described as follows;

Commencing at an iron pin (set) at the common Western corner for Sections #15 & #16 of said Township and Range, also being on the line between Muskingum and Licking Counties; **thence S 01 23 40 W 849.00 feet** along said common County line and West line of Section #16 to the center line of State Route #586 (Black Run Road), being a common corner for the J Randall property recorded in deed reference Deed Book Volume 1136, Page 828 and for the J Hittle property recorded in deed references Deed Book Volume 1134, Page 535 and Deed Book Volume 1136, Page 831, passing iron pins (found) at 636.29 feet, and 801.61 feet; **thence S 38 03 30 E 94.05 feet** into Muskingum County and Section #16, along said road and common line for said J Randall and Hittle properties to a corner of said J Randall property, from which an iron pin (set) on a line of said J Randall property bears for reference N 00 46 20 E 47.87 feet; **thence S 38 03 30 E 545.10 feet** continuing along said road and line for said Hittle property to the place of beginning for the property herein intended to be described;

- #1- **thence N 15 18 20 E 376.53 feet** leaving said road and into said George Randall property to an iron pin (set), passing an iron pin (set) at 38.63 feet;
- #2- **thence N 85 20 30 E 232.99 feet** continuing through said George Randall property to an iron pin (set);
- #3- **thence S 07 22 00 E 193.31 feet** continuing through said George Randall property to an iron pin (set);
- #4- **thence S 64 37 50 W 171.87 feet** continuing through said George Randall property to an iron pin (set);
- #5- **thence S 22 50 30 W 263.58 feet** continuing through said George Randall property to the center line of said road, passing an iron pin (set) at 235.36 feet;
- #6- **thence N 38 03 30 W 160.23 feet** along the center of said road and line for said Hittle to the place of beginning, **containing 2.17 acres.**

The bearings within this description are based on an assumed meridian and are for angular purposes only. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
