

DESCRIPTION FOR CONVEYANCE

BEING A PART OF THE SOUTHWEST AND THE NORTHWEST QUARTER OF SECTION 17,
TOWNSHIP 3, RANGE 9, OF THE UNITED STATES MILITARY LANDS, JACKSON TOWNSHIP,
MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT THE INTERSECTION OF THE CENTER OF TOWNSHIP ROAD NUMBER 316
(CANNON ROAD) AND THE WEST LINE OF SECTION 17, SAID INTERSECTION BEING SOUTH 00
DEGREES 30 MINUTES 00 SECONDS EAST 1124.60 FEET (BY DEED) FROM THE NORTHWEST
CORNER OF THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER OF SECTION 17; THENCE
ALONG THE CENTER OF SAID ROAD AS RECORDED IN DEED VOLUME 842 PAGE 178 OF SAID
COUNTY RECORDS SOUTH 77 DEGREES 25 MINUTES 00 SECONDS EAST 503.14 FEET TO A
POINT SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO
BE DESCRIBED; THENCE CONTINUING ALONG SAID ROAD SOUTH 77 DEGREES 25 MINUTES 00
SECONDS EAST 63.36 FEET TO AN IRON PIN SET IN SAID CENTER; THENCE SOUTH 58
DEGREES 45 MINUTES 00 SECONDS EAST 18.21 FEET TO A POINT IN THE CENTER OF SAID
ROAD, SAID POINT BEING NORTH 58 DEGREES 45 MINUTES 00 SECONDS WEST 28.79 FEET
FROM AN EXISTING ONE INCH SQUARE ROD; THENCE LEAVING SAID ROAD SOUTH 21 DEGREES
59 MINUTES 24 SECONDS WEST 181.12 FEET TO AN IRON PIN SET, PASSING AN IRON PIN
SET AT 31.12 FEET; THENCE NORTH 71 DEGREES 37 MINUTES 23 SECONDS WEST 79.72
FEET TO AN IRON PIN SET; THENCE NORTH 21 DEGREES 41 MINUTES 43 SECONDS EAST
178.72 FEET TO THE PLACE OF BEGINNING, PASSING AN IRON PIN SET AT 164.27 FEET.

CONTAINING 0.335 MORE OR LESS ACRES, SUBJECT TO ALL LEGAL ROAD RIGHT-OF-WAY
OF TOWNSHIP ROAD NUMBER 316 (CANNON ROAD) AND ALL APPLICABLE EASEMENTS.


