LEGAL DESCRIPTION OF 3.661 ACRE TRACT

Situated in the State of Ohio, County of Muskingum, Township of Jackson, being a part of Section 17 and 24 located in the Third Quarter, Township-3 North, Range- 9 West, United States Military Lands, and being a part of that 6.943 acre tract as conveyed to _____ by deed of record in Deed Book _____, Page _____, all references being to those of record in the Recorder's Office, Muskingum County, Ohio, and being more particularly bounded and described as follows:

Commencing at a stone found marking the northwesterly corner of Section 24;

thence along the westerly line of Section 24, **South 00°49'01" East, 442.23 feet** to a point in the centerline of Raiders Road (old State Route 16);

thence along the centerline of Raiders Road the following three (3) courses and distances;

North 45°43'00" East, 321.94 feet to a point of curvature;

northeasterly along the arc of a curve to the right (**Radius = 2864.93', Delta = 12°02'58"**), a chord bearing and distance of **North 51°44'29" East, 601.39 feet** to a point on tangency; and . . .

North 57°46'00" East, 328.57 feet to a point and being the **Point of Beginning** for the 3.661 acre parcel herein to be described;

thence **North 35°29'56" West, 294.88 feet** to an iron pin set, passing an iron pin set at 30.05 feet;

thence **North 40°13'06" East, 416.95 feet** to an iron pin found;

thence **South 44°57'18" East, 430.69 feet** to a point in the centerline of Raiders Road, passing an iron pin found at 399.93 feet;

thence along the centerline of Raiders Road, **South 57°46'00" West, 475.59 feet** to the **Point of Beginning** and containing **3.661 acres**, more or less, according to a survey made by Jobes Henderson & Associates, Inc., during March of 2004.

The bearings in the above described parcel are based on bearings taken from the Ohio Department of Transportation right-of-way plans for old State Route 16 entitled "SR 16 MUS-16-0-00".

All iron pins set are 5/8" in diameter rebar by 30" in length with red surveyors identification caps marked "J&H, PS 7900".

Subject to all valid and existing easements, restrictions, and conditions of record.

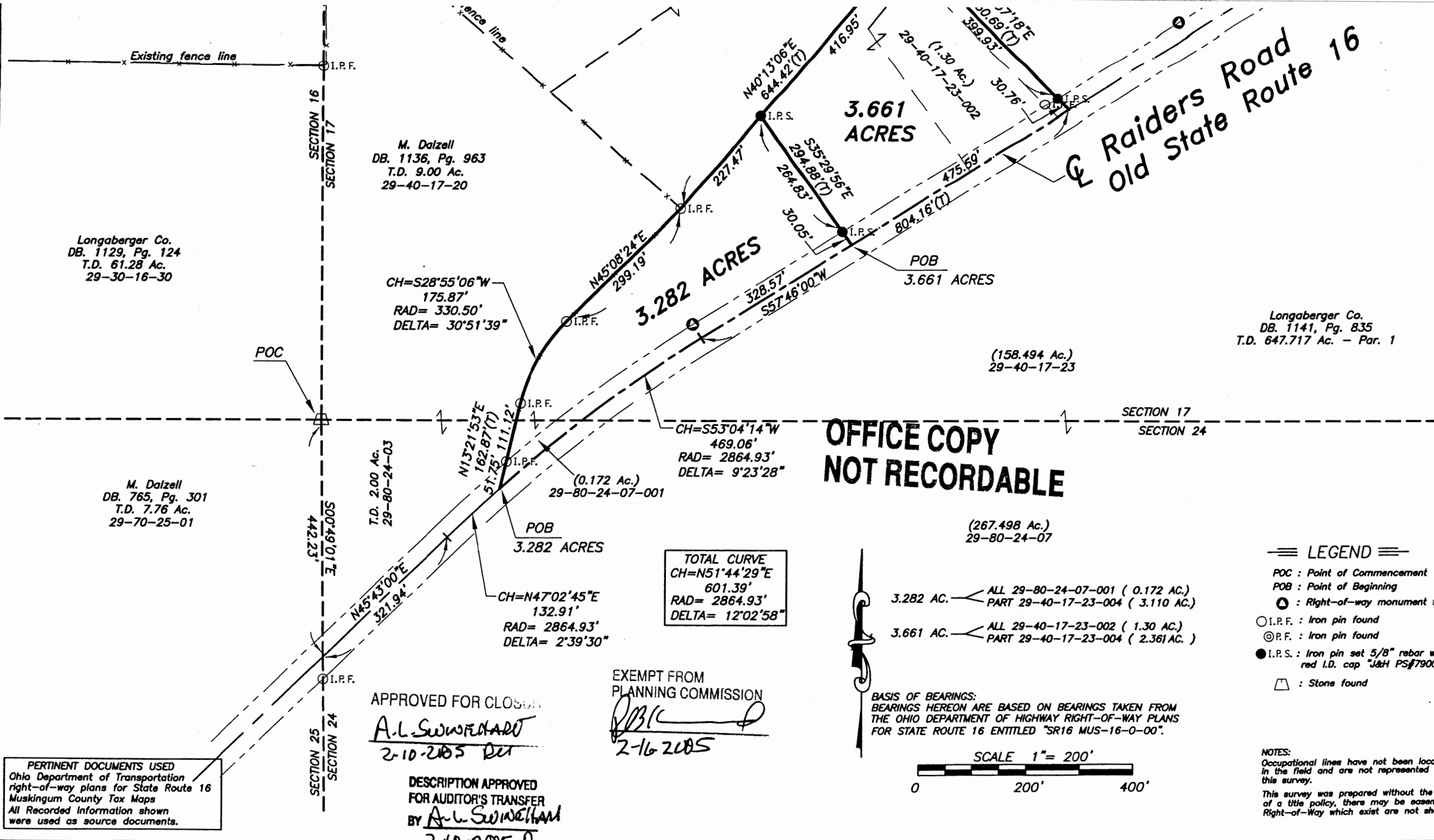

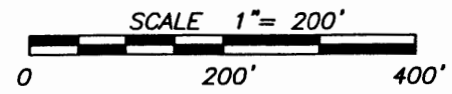
