Beginning at the Southeast corner of lot 17 as recorded in the plat of Rolla Hills Subdivision, located, S.89°50'17"W. a distance of 1,011.18 feet from the Southeast corner of the Northeast Quarter of Section 17;

Thence, **S.89°50'17"W.** a distance of **64.52** feet along the south line of said Subdivision to a point;

Thence, **N.00°31'30"W.** a distance of **1,336.90** feet along the West line of said Subdivision to a point;

Thence, **N.89°50'19"E.** a distance of **1,060.53** feet along the North line of said subdivision to a point;

Thence, **S.01°10'30"E.** a distance of **426.87** feet along said East line of Said subdivision to a point on the North line of the lands of the State of Ohio (1502/769);

Thence, **S.46°52'22"W.** a distance of **816.97** feet along said state lands to a point on the Northern line of Alice Court;

Thence, **N.47°20'03"W.** a distance of **138.77** feet along Alice Court to a point on the East line of Rolla Drive;

Thence, on a curve to the left an arc distance of 94.13 feet with a radius of 150.00 feet whose chord bears, **N.13°05'23"E.** a distance of **92.60** feet along said Drive to a point;

Thence, **N.04°49'06"W.** a distance of **310.49** feet along said drive to a point;

Thence, on a curve to the left an arc distance of 261.77 feet on a radius of 50.00 feet whose chord bears, **S.85°10'20"W.** a distance of **50.00** feet along said Drive to a point;

Thence, **S.04°49'06"E.** a distance of **306.41** feet along said drive to a point;

Thence, **S.04°53'27"E.** a distance of **173.88** feet along said drive to a point;

Thence, on a curve to the right an arc distance of 62.75 feet on a radius of 100.00 feet whose chord bears, **S.13°05'23"W.** a distance of **61.73** feet along said Drive to a point;

Thence, **S.31°04'05"W.** a distance of **276.73** feet along said Drive to a point;

Thence, **S.24°35'55"W.** a distance of **260.86** feet along said Drive to the point of Beginning.

The above described parcel contains 20.272 acres, more or less, and is subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.




