

Re-Survey of Francine A. Norman Lands in Jackson Township, Muskingum County

Situated in the State of Ohio, County of Muskingum, Township of Jackson, and being part of the Northeast Quarter of Section 18, Township 3, Range 9, United States Military Lands, and being all the lands presently owned by Francine A. Norman as per Official Record 3081, Page 254, and being more particularly described as follows:

Beginning for reference at a point in the right of way of State Route 16, at the northwest corner of the Northeast Quarter of Section 18, Township 3, Range 9, United States Military Lands;

Thence across said State Route, and through the lands presently owned by Levi E. Heimberger, (OR 2938-353), South 44 degrees 21 minutes 32 seconds East, 1349.28 feet to an iron pin found, on a south line of said Heimberger lands, and the principal place of beginning;

Thence along the lines of said Heimberger lands the following four courses:

- 1.) North 19 degrees 07 minutes 46 seconds East 433.38 feet to an iron pin found;
- 2.) South 82 degrees 35 minutes 22 seconds East, 114.64 feet to an iron pin found;
- 3.) North 09 degrees 56 minutes 16 seconds East, 267.40 feet to an iron pin found;
- 4.) South 88 degrees 11 minutes 58 seconds East, 329.79 feet to a point in the centerline of Wakatomika Creek, passing an iron pin found at 235.56 feet, and the centerline of Hamby Hill Road, (Co. Rd. 38), at 250.73 feet;

Thence along the centerline of said creek, the following six courses:

- 1.) South 15 degrees 50 minutes 40 seconds East, 235.67 feet to a point;
- 2.) South 37 degrees 36 minutes 39 seconds East, 184.75 feet to a point, from which an iron pin found bears North 52 degrees 58 minutes 03 seconds East, 104.93 feet;
- 3.) South 69 degrees 46 minutes 58 seconds East, 269.51 feet to a point;
- 4.) South 44 degrees 03 minutes 12 seconds East, 177.93 feet to a point;
- 5.) South 00 degrees 07 minutes 13 seconds East, 216.17 feet to a point, from which an iron pin found bears South 39 degrees 09 minutes 36 seconds East, 64.25 feet;
- 6.) South 56 degrees 31 minutes 16 seconds West, 310.00 feet to a point on the east line of lands presently owned by G & G Land Holdings LLC, (OR 2973-283), from which an iron pin found bears North 69 degrees 12 minutes 14 seconds East, 189.92 feet;

Thence along the lines of said G & G lands the following seven courses:

- 1.) North 44 degrees 35 minutes 54 seconds West, 164.83 feet to an iron pin set;
- 2.) North 27 degrees 12 minutes 43 seconds West, 292.55 feet to an iron pin set;
- 3.) North 60 degrees 36 minutes 43 seconds West, 112.35 feet to an iron pin set;
- 4.) North 71 degrees 42 minutes 43 seconds West, 94.45 feet to an iron pin set;
- 5.) South 63 degrees 10 minutes 54 seconds West, 134.43 feet to an iron pin set;
- 6.) South 35 degrees 42 minutes 49 seconds West, 95.85 feet to an iron pin set;
- 7.) North 88 degrees 13 minutes 26 seconds West, 74.63 feet to a point in the centerline of Norman Drive, (Twp. Rd. 632A), and the northeast corner of said Heimberger lands, passing an iron pipe found at 64.73 feet;

Thence along the north line of said Heimberger lands, North 88 degrees 13 minutes 26 seconds West, 239.60 feet to the principal place of beginning, containing 12.36 acres, more or less, and being all of Auditor's Parcel Number 29-40-18-04-000.
