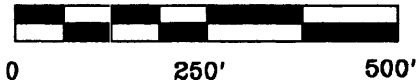

TOWNSHIP, MUSKINGUM COUNTY, OHIO.

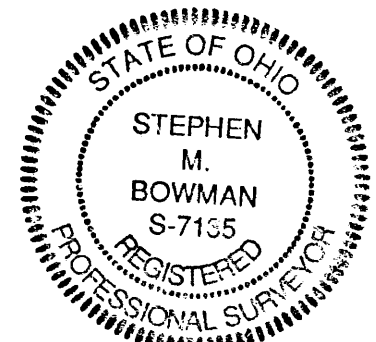

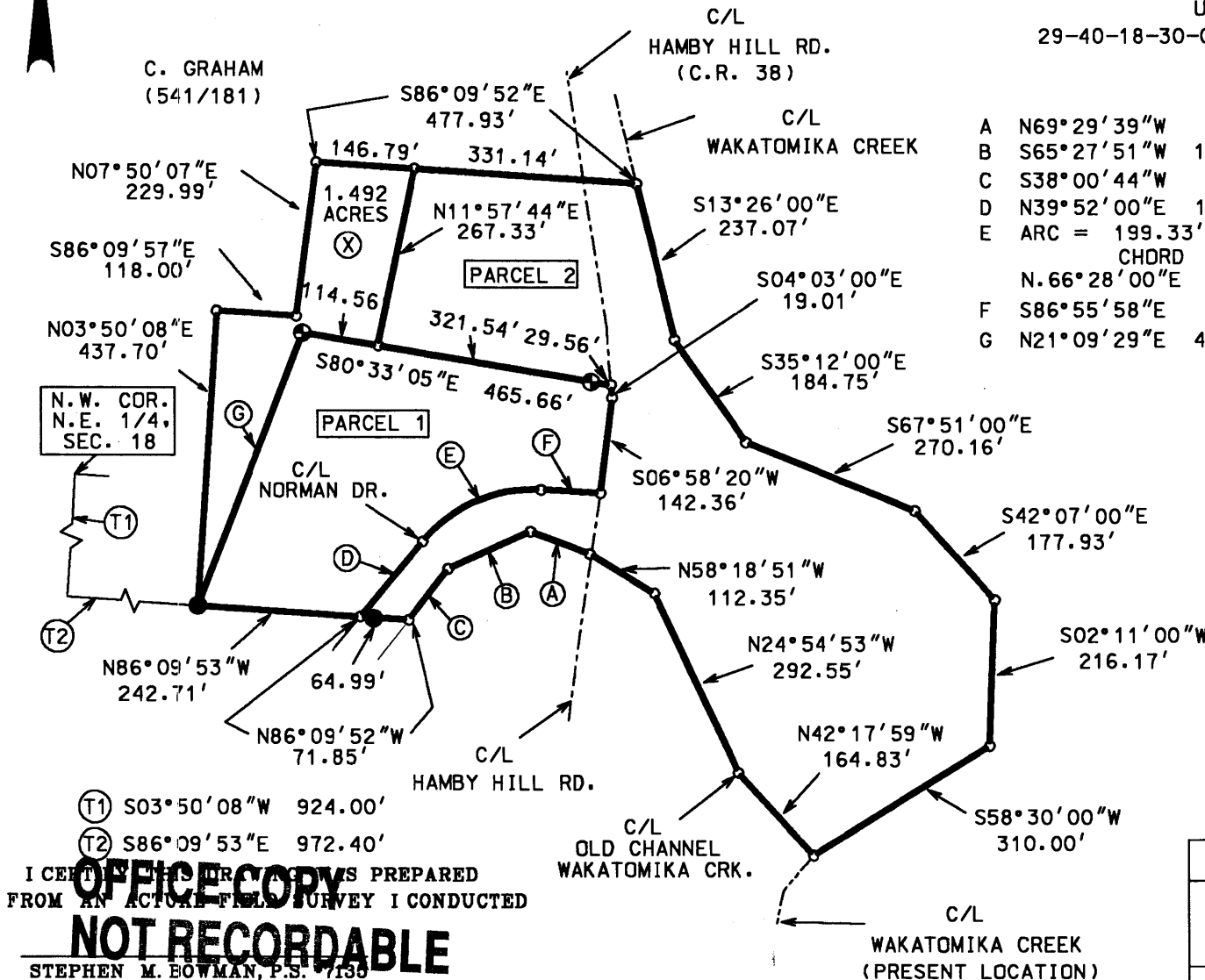
