Situated in the Village of Frazeytsburg, Muskingum County, Ohio. Being the part of lot #35 of Chaney's Third Addition as recorded in Plat Book 1 page 222 of the Muskingum County Plat records and being described as follows:

Beginning at the Southwest corner of lot #35 of Chaney's Third Addition (P.B. 1, Pg. 222);

thence, **N.00°00'00"E.** a distance of 95.17 feet along the east line of Basin Street to a set rebar;

thence, **S.89°42'30"E.** a distance of 66.83 feet through lot #35 to a set rebar on the west line of lot #34;

thence, **S.00°00'00"E.** a distance of 94.83 feet along said lot 34 to a set rebar on the North line of Fourth Street;

thence, **N.90°00'00"W.** a distance of 66.83 feet along said Street to the point of beginning.

The above described parcel contains 0.146 acres, more or less, and is subject to all legal easements and right of ways. All set iron pins are 5/8" x 30" rebars with I.D. caps. North is based an assumed meridian.

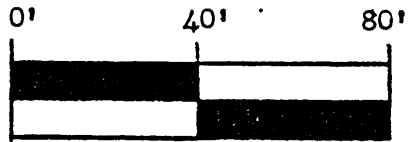

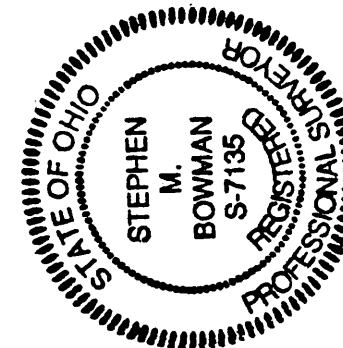
