Situated in the Village of Frazeyburg, Muskingum County, Ohio Being part of lot #09 of the Town Plat of Frazeyburg (Formerly the Town of Knoxville), recorded in Deed Book I page 250 of the Muskingum County deed records and being described as follows:

Beginning at the Southeast corner of lot #10;
thence, S.90°00'00"E. a distance of 2.00 feet along the North line of Second Street to a set iron pipe;
thence, N.00°10'00"E. a distance of 50.00 feet through lot #09 to a set iron pipe;
thence, N.90°00'00"W. a distance of 2.00 feet through lot #09 to a set iron pipe on the East line of lot #10;
thence, S.00°10'00"W. a distance of 50.00 feet along the east line of said lot to the point of beginning.

The above described parcel contains 0.002 acres, more or less, and is subject to all legal easements and right of ways. All set iron pipes are 3/4" x 30" pipes with plastic I.D. caps. North is based an assumed meridian.

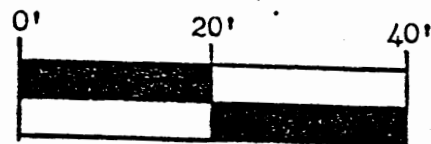

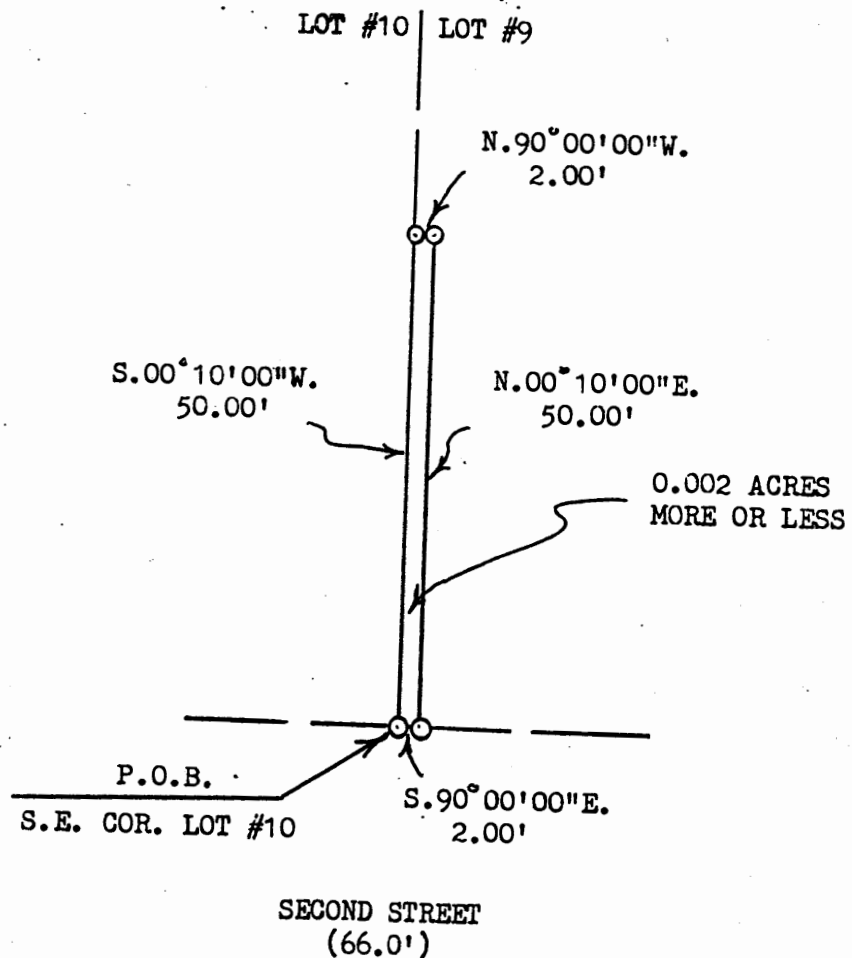
