Situated in the Village of Fazeysburg, Muskingum County, Ohio. Being part of lot 8 of the Town Plat of Fazeysburg (formerly Knoxville) recorded in the Muskingum County Plat records and being described as follows:

Beginning at a set rebar in the Southwest corner of lot 8 of the Town plat of Fazeysburg;

Thence, N.00°00'00"E. a distance of 104.72 feet along the West line of Lot 8 to a set rebar;

Thence, S.90°00'00"E a distance of 82.50 feet through lot 8 to a set rebar on the East line of said lot;

Thence, S.00°00'00"W. a distance of 104.72 feet along said lot line to a point on the Southeast corner of said lot;

Thence, S.90°00'00"W. a distance of 82.50 feet along South line of said lot to the point of beginning.

The above described parcel contains 0.198 acres and is subject to any legal easements and rights of way.

Also attached to the above described parcel is subject to a 10 foot wide easement along the entire North side of said parcel for the purpose of maintaining existing utility lines servicing the North portion of lot 8.

North is based upon an assumed meridian. All set rebars are 5/8" x 30" rebars with ID caps. Description was by Bowman Surveying, Stephen M. Bowman, P.S.#7135. April 9, 2001.
