**SURVEY DESCRIPTION
FOR
PROPOSED VACATION OF
APORTION OF NORTH CANAL STREET
FRAZEYSBURG**

0.02 ACRES

Situated in North Canal Street, along the East side of lot 64 and portions of lots 62 and 65, of the Town Plat of Frazeytsburg (formerly Knoxville), Village of Frazeytsburg, Muskingum County, Ohio.

Commencing at the Southwest corner of lot 64 of the Town plat of Frazeytsburg (Formerly Knoxville) recorded in Plat Book 1, Page 250 of the Muskingum County Plat records;

Thence, S.00°00'00"E. a distance of 23.50 feet along the East line of Basin Street to a set rebar on the Northwest corner of the lands, now or formerly, owned by G. & D. Peterson (1062/611);

Thence, N.90°00'00"E. a distance of 131.75 feet along said Peterson lands to a point on the Western line of North Canal Street, **BEING THE POINT OF BEGINNING;**

Thence, N.38°48'19"E. a distance of 30.16 feet along said East line of lot 65 to a point on the Southeast corner of Lot 64;

Thence, N.45°39'59"E. a distance of 20.06 feet along lot 64 to a point on the Southwest corner of lot 62;

Thence, N.42°14'38"E. a distance of 38.67 feet along lot 62 to a set rebar;

Thence, S.27°22'19"W. a distance of 74.49 feet through North Canal Street to a set rebar;

Thence, N.90°00'00"W. a distance of 25.00 feet through North Canal Street to the point of beginning.

The above described parcel contains 0.02 Acres, more or less, subject to all legal easements and right of ways. All set rebars are 5/8" x 30" rebars with plastic I.D. caps. North is based upon an assumed meridian.

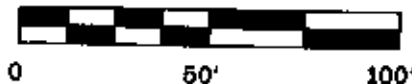
