

Situated in the Southeast Quarter of Section 19, in the 4th Quarter of Township 3 North, Range 9 West of the United States Military Lands, and in the Village of Frazeyburg, Muskingum County, Ohio, [and being all of the property conveyed to James Marshall by a deed recorded in Deed Book 2242, page 719 (Aud. Par. #29-61-25-06-000,all)] and being further bounded and described as follows:

Beginning for a point of reference at a 1 inch rebar found at the northwest corner of Lot 63 of the Plat of Knoxville (now Frazeyburg) as recorded in Deed Book I, page 250;

thence South 01° 00' 00" East, along the east line of South Basin Street (formerly West Street) and passing a 1 inch pipe found on the south line of Goff's Alley, a total distance of 410.99 feet to a 1 inch pipe found, **said point being the true place of beginning of this tract;**

thence South 88° 58' 00" East, along the south line of a tract conveyed to Virginia R. King by a deed recorded in Deed Book 1049, page 480, a distance of 142.48 feet a 1 inch pipe found on the northwesterly line of South Canal Street;

thence South 40° 38' 00" West, along the northwesterly line of South Canal Street and passing an axle found at a distance of 196.09 feet, a total distance of 211.54 feet to a point at the intersection of the northwesterly line of South Canal Street and the east line of South Basin Street;

thence North 01° 38' 00" West, along the east line of South Basin Street and passing an axle found at a distance of 11.77 feet, a total distance of 163.14 feet to the place of beginning.

Containing 0.267 acres, subject to any valid and existing easements, restrictions, leases or other conditions of record.

The bearings used in this description are based on the bearings in a deed recorded in Deed Book I, page 250 of the Muskingum County Deed Records. 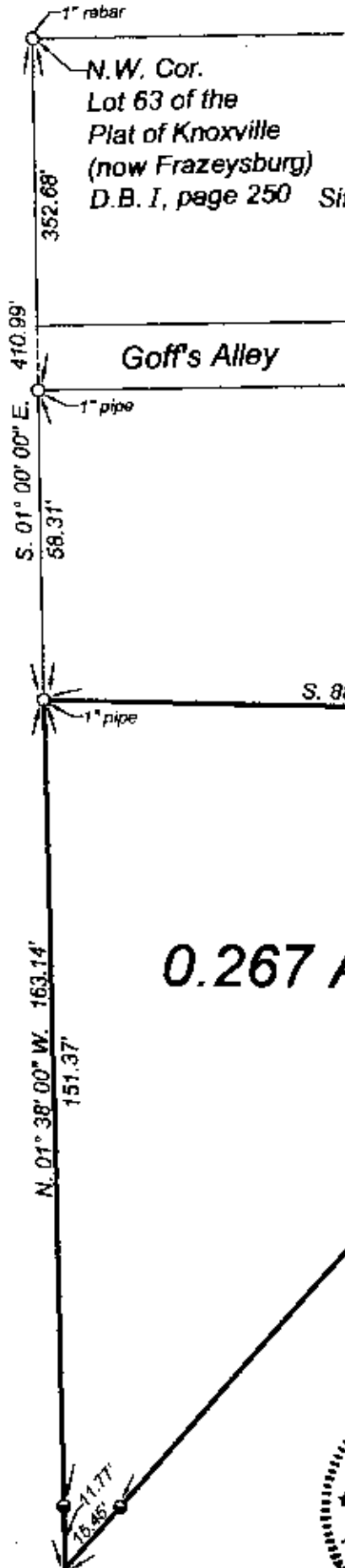

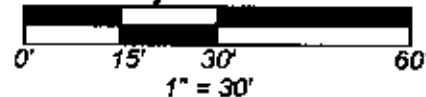
