**RESURVEY OF AUDITORS PARCELS
29-61-27-12-000 (ALL)**

Situated in the Village of Frazeytsburg, Muskingum County, Ohio. Being the lands of F. M. Riley as conveyed in Parcel 2 of Deed Book 1135 page 568 of the Muskingum County Deed records, also known as lot 47 of Beard Subdivision (P.B. 9 Pg. 60) and being described as follows:

Beginning at a found iron pipe marking the Southeast corner of lot #23 of Beard Subdivision (P.B. 9, Pg. 60);

thence, **S.00°10'00"W.** a distance of 82.50 feet along the West line of Beard road to a point on the Northeast corner of the lands of F.M. Riley, (parcel 1, D.B. 1135/568), also known as the Northeast corner of lot 46 of Beard Sub.;

thence, **N.90°00'00"W.** a distance of 153.00 feet along the North line of said Riley Parcel 1, and the North line of said lot to a point on the East line of a 16.5' alley;

thence, **N.00°10'00"E.** a distance of 82.50 feet along the East line of said alley to a point, being the Southwest corner of lot 23 of Beard Sub.;

thence, **N.90°00'00"E.** a distance of 153.00 feet along the South line of said lot 23, passing a set rebar at 6.47 feet, to the point of beginning.

The above described parcel contains 0.290 acres, more or less, and is subject to all legal easements and right of ways. North is based an assumed meridian. All set rebars are 5/8"x 30" rebars.

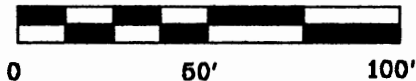

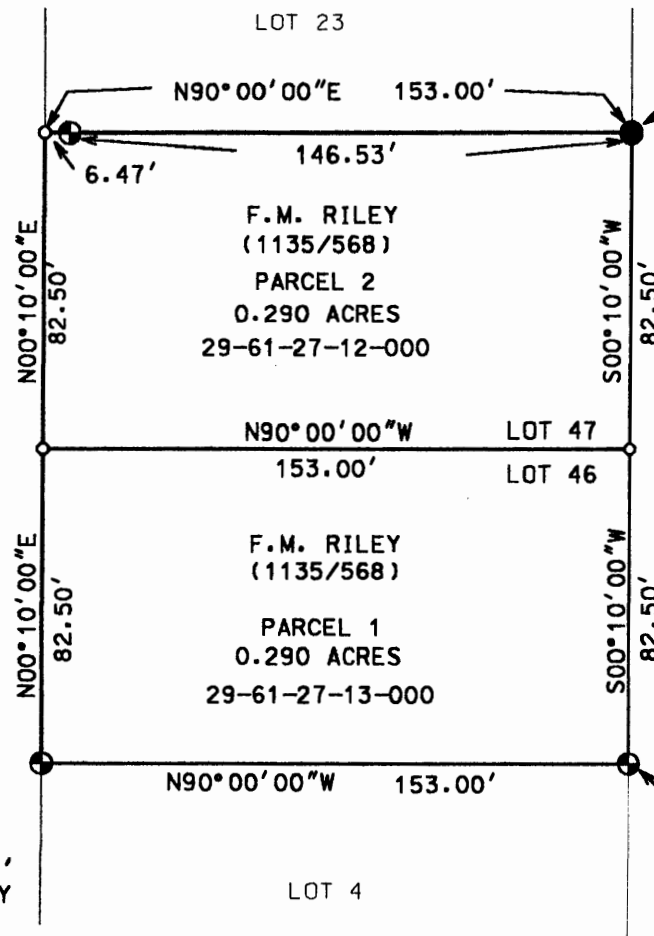
