**SURVEY DESCRIPTION**

PARCEL 1

**PART OF PARCEL**

#29-62-01-01-000 (0.208 ACRES)  
#29-63-02-11-000 (0.085 ACRES)

Situated in the Village Of Frazeytsburg, Sections #19 and #20, T-3-N, R-9-W, Muskingum County, Ohio. Being part of lands of William and Carol Spellman as conveyed in Deed Book 579 page 372 of the Muskingum County deed records and being described as follows:

Commencing at a railroad spike marking the Northwest corner of the Southwest quarter of section #20; thence, S.00°04'20"W. a distance of 222.343 feet along the West line of said quarter section to a point on the South line of the lands, now or formerly, owned by S. & R. Bowman (1086/045), commonly known as Stevy Lane, BEING THE POINT OF BEGINNING;

thence, S.88°06'27"E. a distance of 32.47 feet along said lane to a set rebar;

thence, S.01°41'26"W. a distance of 120.00 feet through the lands of W. & C. Spellman (579/372) to a set rebar;

thence, N.88°06'27"W a distance of 105.00 feet through said Spellman lands to a set rebar;

thence, N.01°41'26"E. a distance of 134.09 feet through said Spellman lands to a set rebar on the South line of Stevy Lane;

thence, on a curve to the left an arc distance of 28.50 feet, on a radius of 79.00 feet, whose chord bears S.58°17'43"E. a distance of 28.34 feet along Stevy Lane to a found rebar;

thence, S.88°06'27"E. a distance of 47.99 feet along said Lane to the point of beginning.

The above described parcel contains 0.293 acres, more or less, ( 0.208 acres in section 19 and 0.085 acres in section 20) and is subject to all legal easements and right of ways. All set iron pipes are 5/8" x 30" rebars. North is based upon an assumed meridian.

Also attached is a right of way for ingress and egress from Spellman lane along Stevy lane (currently a private drive) as described in parcels 1 and 2 of deed book 1086 page 045.

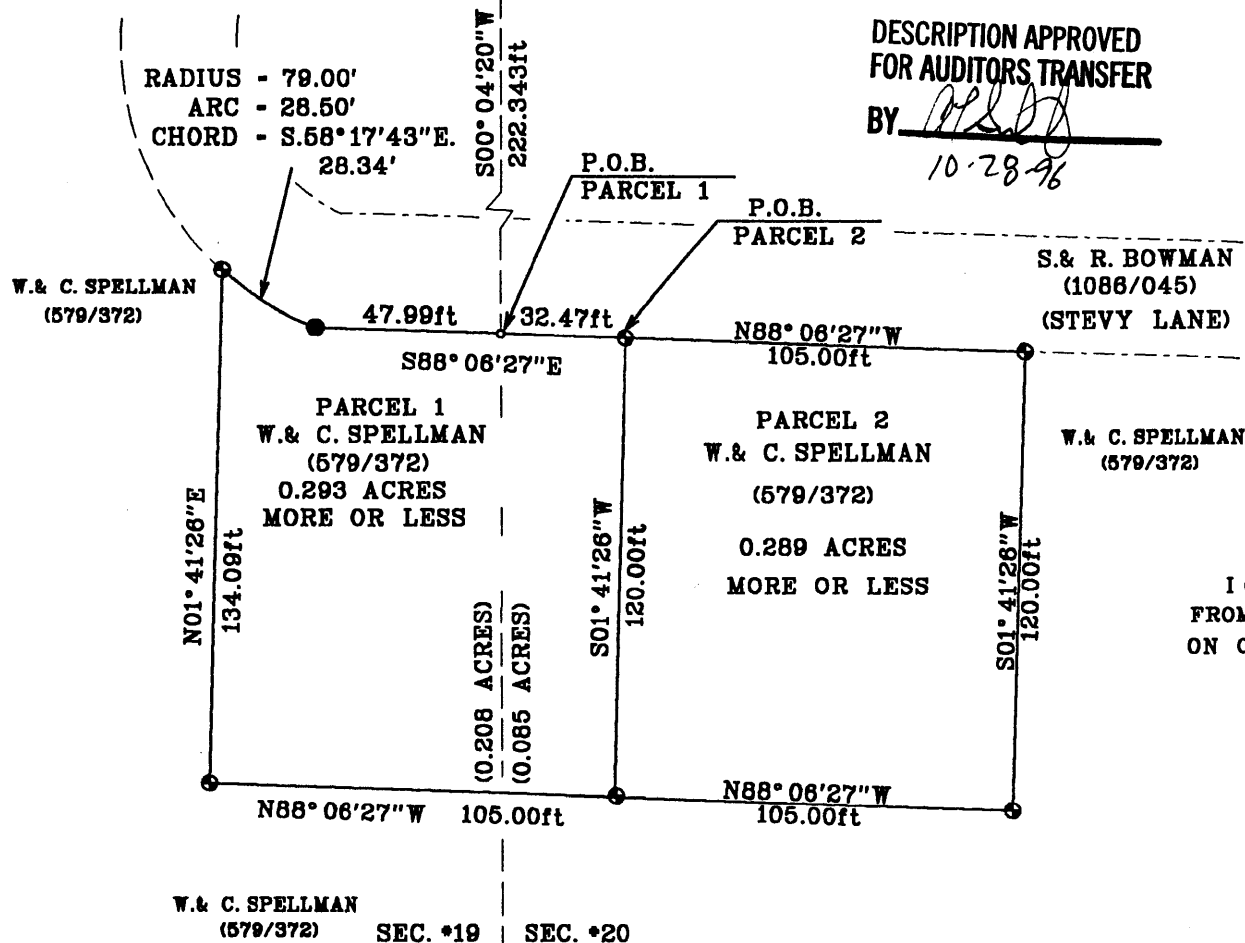
