Situated in the Southeast quarter of Section #19, T-3-N, R-9-W, U.S.M.L., Jackson Township, Village of Frazeytsburg, Muskingum County, Ohio. Being a the lands of Ross Johnston as recorded in Deed book 536, page 507 of the Muskingum County Deed records and being more particularly described as follows:

Commencing at the intersection of the West line of the Southeast quarter of section #19 and the South Corporation line of the Village of Frazeytsburg as recorded in Plat book 10 page 30, being referenced by a found concrete post bearing S.89°38'58"W. at 1.44 feet; thence, N.89°38'58"E. a distance of 528.74 feet along the said South Corporation line to a set iron pin on the Southeasterly line of Canal Road, BEING THE POINT OF BEGINNING; thence, N.40°33'12"E. a distance of 211.91 feet along said road to a set iron pin at the Northwest corner of J. & M. Ridgway (944/161); thence, S.28°07'44"E. a distance of 181.03 feet along the West line of said Ridgway lands and along the West line of H. & B. Myers (620/144) to a set iron pin on the South Corporation line of Frazeytsburg; thence, S.89°38'58"W. a distance of ~~222.13~~ **223.13** feet along said Corporation line to the point of beginning.

The above described parcel contains 0.410 acres, more or less, and is subject to all legal easements and right of ways. North is based upon an assumed meridian. All set iron pins are 3/4" x 30" pipes with I.D. caps.

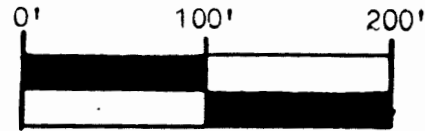

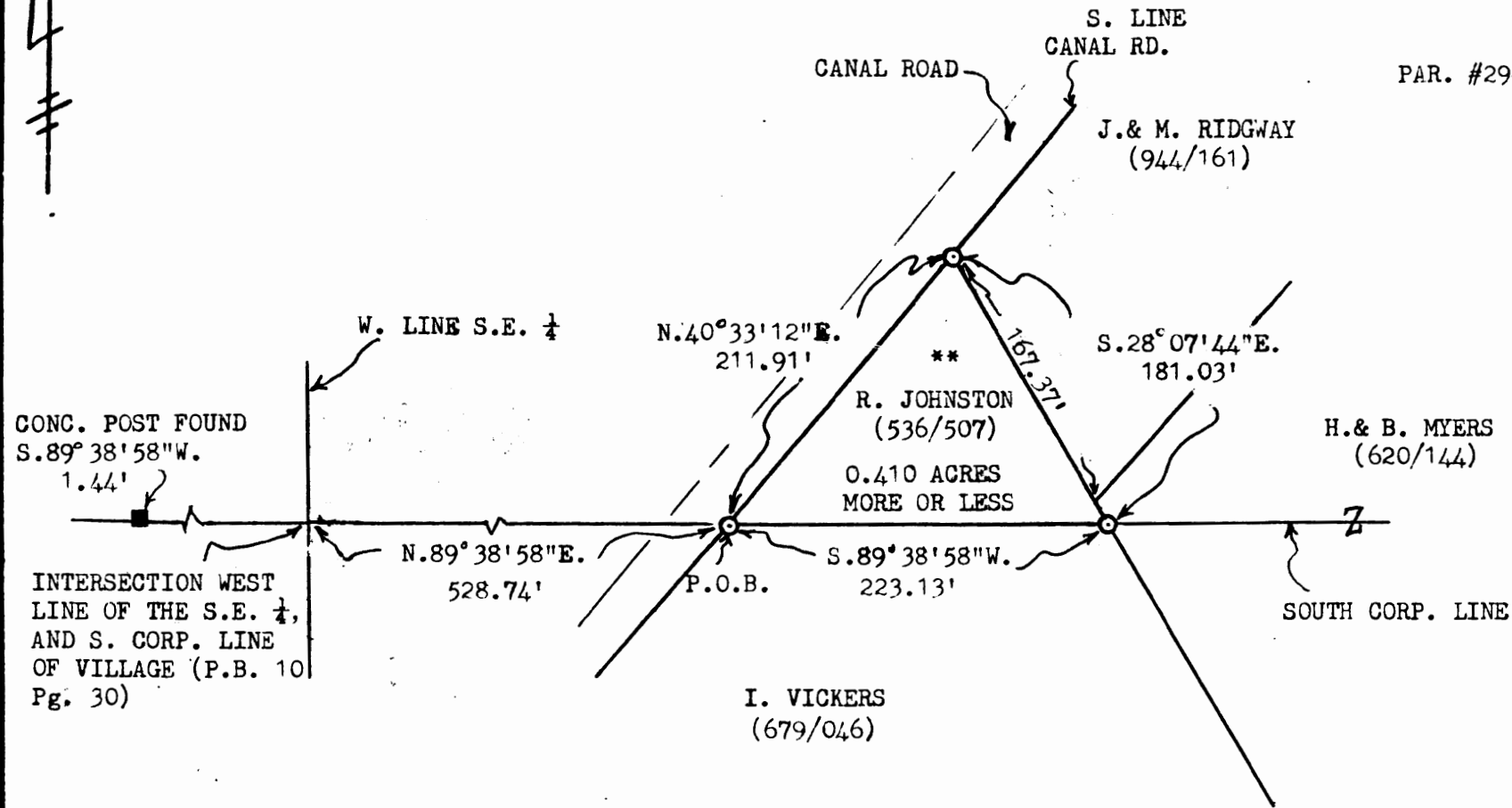
