Situated in the Southwest quarter of section #24 and the Southeast quarter of section #25, T-3-N, R-9-W, Jackson Township, Muskingum County, Ohio. Being parcel a 29.372 acre parcel out of the lands of Ruth Ardrey as conveyed in deed book 585 page 204 of the Muskingum County deed records and being described as follows:

Beginning at a set iron pipe on the South line of section #25, being N.89°14'12"W. a distance of 497.50 feet from the Southeast corner of section #25;

thence, N.16°17'16"W. a distance of 911.32 feet along the East line of the lands, now or formerly, owned by I. Westbrook (1030/192) to a found iron pipe;

thence, N.67°24'13"E. a distance of 1,308.43 feet along said Westbrook lands to a found iron pipe;

thence, N.01°13'47"W. a distance of 321.22 feet along said Westbrook lands to a point in the center of State Route #586, passing a found iron pipe at 271.28 feet;

thence, S.43°27'52"E. a distance of 127.50 feet through said route to a point;

thence, S.40°13'54"E. a distance of 176.75 feet through said route to a point;

thence, S.30°24'50"E. a distance of 108.24 feet through said route to a point;

thence, S.66°30'26"W. a distance of 759.95 feet along the north line of the lands, now or formerly, owned by the Ohio Oil Gathering Corp. (725/115 & 939/207) to a found iron pin, passing a found iron pin at 41.47 feet;

thence, S.22°40'14"E. a distance of 493.73 feet along said Oil lands to a point in a small stream, passing a found iron pin at 452.73 feet;

thence, N.51°06'49"E. a distance of 51.75 feet along said stream to a point;

thence, N.44°53'22"E. a distance of 73.35 feet along said stream to a point;

thence, N.75°10'57"E. a distance of 65.25 feet along said stream to a point;

thence, N.76°12'45"E. a distance of 132.41 feet along said stream to a point on the West line of the National Oil & Gas Corp. (731/094) lands.;

thence, S.22°40'14"E. a distance of 439.92 feet along said Gas lands to a found iron pin;

thence, N.67°23'30"E. a distance of 443.84 feet along said Gas lands to a point in the right of way of State Route 586, passing a set iron pin at 419.03 feet;

thence, S.22°59'12"E. a distance of 59.66 feet through said State Route to a point;

thence, S.66°40'30"W. a distance of 512.98 feet through the lands, now or formerly, owned by Ruth Ardrey (585/204) to a set iron pipe, passing a set iron pipe at 24.52 feet;

thence, S.23°23'43"E. a distance of 299.71 feet through said Ardrey lands to a set iron pipe on the South line of section #24;

thence, N.89°14'12"W. a distance of 1,229.94 feet along the south lines of section #24 and #25 to the point of beginning.

The above described parcel contains 29.372 acres, more or less, (13.952 acres in section #24 and 15.420 acres in section #25) and is subject to all legal easements and right of ways. all set iron pipes are 3/4" x 30" pipes with plastic I.D. caps. North is based upon an assumed meridian.

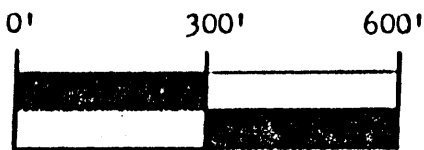
