Thence with the centerline of said Township Road 642, and with a new division line into said Section 19 and said Parcel 1 (Kathleen Hedges Tract), the following three (3) courses and distances:

- 1.) Thence N 66°51'21" E a distance of 119.83 feet to a 5/8" rebar set;
- 2.) Thence N 58°25'50" E a distance of 194.32 feet to a 5/8" rebar set;
- 3.) Thence N 68°28'32" E a distance of 170.11 feet to a point, said point being the northwest corner of a tract of land described in a deed to Ronald G. & Barbara K. Wolfe recorded in DB.999 Pg.93;

Thence S 01°17'55" E leaving the centerline of said road, and with the west line of said Wolfe Tract, passing through a 5/8" rebar set at 21.31 feet, a total distance of 136.57 feet to a 5/8" rebar set at the southwest corner of said Wolfe Tract;

Thence N 88°42'05" E with the south line of said Wolfe Tract, a distance of 459.55 feet to a 5/8" rebar found at the southeast corner of said Wolfe Tract, in the east line of said Section 19, and in the east line of said Parcel 1 (Kathleen Hedges Tract);

Thence S 00°19'30" E with the east line of said Section 19 and the east line of said Parcel 1 (Kathleen Hedges Tract) a distance of 80.37 feet to the point of beginning and containing 56.828 acres of land, more or less. Subject to all easements, leases, conditions, covenants, and right-of-way of record.

56.828 ACRE DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Jackson, and being a part of the Southeast Quarter of Section 19 and the Northeast Quarter of Section 22, Township 3, Range 9, of the United States Military Lands. Being also a part of Parcel 1, and all of Parcels 2 and 3 as described in a deed to Jessie Kathleen Hedges (hereinafter referred to as Kathleen Hedges) recorded in Deed Book 973 Page 261, all references to Deed Book (DB.) refer to the records of the Muskingum County Recorder's Office, Zanesville, Ohio. Said 56.828 acre parcel being further bounded and described as follows:

Beginning at a stone with "x" found at the northeast corner of said Section 22, said stone being the northeast corner of said Parcel 2 (Kathleen Hedges Tract), being the southeast corner of said Parcel 1 (Kathleen Hedges Tract), and being the northwest corner of a tract of land described in a deed to Stephen McCann et al. recorded in DB.1129 Pg.364;

Thence S 00°00'00" E with the east line of said Section 22, the east line of said Parcel 2 and Parcel 3 (Kathleen Hedges Tracts), and with the west line of said McCann Tract a distance of 2672.64 feet to a stone found at the southeast corner of said Parcel 3 (Kathleen Hedges Tract), a southwest corner of said McCann Tract, and said stone being the southeast corner of the northeast quarter of Section 22;

Thence S 89°46'27" W with the south line of said Parcel 3 (Kathleen Hedges Tract), the south line of the northeast quarter of said Section 22, and with the north line of a tract of land described in a deed to John J. Nethers recorded in DB.970 Pg.315, a distance of 594.00 feet to a 5/8" rebar set at the southwest corner of said Parcel 3 (Kathleen Hedges Tract), and being the southeast corner of a tract of land described in a deed to Dorothy P. Vickers recorded in DB.451 Pg.299;

Thence with the west line of said Parcel 3 (Kathleen Hedges Tract), the east line of said Vickers Tract, and with an existing fenceline, the following seven (7) courses and distances:

- 1.) Thence N 00°31'46" W a distance of 314.16 feet to a 5/8" rebar set;
- 2.) Thence N 19°23'50" W a distance of 596.64 feet to a 5/8" rebar set;
- 3.) Thence N 15°35'46" W a distance of 895.79 feet to a 5/8" rebar set;
- 4.) Thence N 28°03'53" W a distance of 79.86 feet to a 5/8" rebar set;
- 5.) Thence N 11°21'14" E a distance of 148.50 feet to a 5/8" rebar set;
- 6.) Thence N 18°12'49" W a distance of 217.80 feet to a 5/8" rebar set;
- 7.) Thence N 03°02'43" W a distance of 528.00 feet to a 5/8" rebar set at the northwesterly corner of said Parcel 3 (Kathleen Hedges Tract), and at a northeasterly corner of said Vickers Tract;

Thence S 50°47'43" E leaving the said Vickers Tract, and with the northerly line of said Parcel 3 (Kathleen Hedges Tract), a distance of 33.00 feet to a 5/8" rebar set in the north line of said Section 22, said point being the northwest corner of said Parcel 2 (Kathleen Hedges Tract) and the southwest corner of said Parcel 1 (Kathleen Hedges Tract);

Thence N 89°41'48" E with the north line of said Section 22, the line common to said Parcel 1 and Parcel 2 (Kathleen Hedges Tracts), a distance of 217.81 feet to a 5/8" rebar set in the centerline of Township Road 642 (also known as Hedges Lane);
