THENCE WITH THE NORTH LINE OF WEST 8TH STREET (FORMERLY KNOWN AS NORTH STREET), NORTH 67 DEGREES 24 MINUTES 04 SECONDS EAST, PASSING EXISTING IRON PINS (5/8 INCH REBARS) AT 337.17 FEET AND 377.17 FEET, A TOTAL DISTANCE OF 457.17 FEET TO AN IRON PIN SET AT THE SOUTHEAST CORNER OF A PARCEL CONVEYED TO JAMES D. AND DARLENE S. HINDEL IN DEED VOLUME 1095, PAGE 125, SAID IRON PIN SET BEING THE **PLACE OF BEGINNING** FOR THE EASEMENT HEREIN INTENDED TO BE DESCRIBED;

THENCE WITH THE EAST LINE OF THE SAID HINDEL PARCEL, NORTH 22 DEGREES 38 MINUTES 08 SECONDS WEST 70.88 FEET TO AN IRON PIN SET;

THENCE LEAVING THE SAID HINDEL EAST LINE AND TRAVERSING INTO THE ABOVE SAID LITTLE PARCEL, NORTH 67 DEGREES 24 MINUTES 04 SECONDS EAST 2.50 FEET TO A POINT, SAID POINT BEING SOUTH 67 DEGREES 24 MINUTES 04 SECONDS WEST 77.50 FEET FROM AN IRON PIN SET;

THENCE CONTINUING THROUGH THE SAID LITTLE PARCEL THE FOLLOWING THREE COURSES AND DISTANCES:

1. SOUTH 23 DEGREES 43 MINUTES 02 SECONDS EAST 14.69 FEET TO A POINT AT THE NORTHWEST CORNER OF A HOUSE;
2. WITH THE WEST LINE OF THE SAID HOUSE, SOUTH 22 DEGREES 04 MINUTES 24 SECONDS EAST 40.40 FEET TO THE SOUTHWEST CORNER OF THE SAID HOUSE;
3. SOUTH 23 DEGREES 04 MINUTES 05 SECONDS EAST 15.79 FEET TO A POINT ON THE NORTH LINE OF THE SAID WEST 8TH STREET, SAID POINT BEING SOUTH 67 DEGREES 24 MINUTES 04 SECONDS WEST 77.50 FEET FROM AN IRON PIN SET;

THENCE WITH THE NORTH LINE OF THE SAID WEST 8TH STREET, SOUTH 67 DEGREES 24 MINUTES 04 SECONDS WEST 2.50 FEET TO THE **PLACE OF BEGINNING**;
