Situated in the State of Ohio, County of Muskingum, Township of Licking and being part of Quarter Township 2, Township 2, Range 9 of the United States Military Lands and being more particularly bounded and described as follows:

Beginning at a nail set on the East line of said Quarter Township 2 at the intersection of Co. Rd. #545, also known as Vickers Hill Road.

Thence, along said Quarter Township line, South - 01 Degrees - 28 minutes - 37 seconds - East, 771.28 feet to an iron pin found.

Thence, South - 88 Degrees - 34 minutes - 42 seconds - West, 285.00 feet to an iron pin set and the true place of beginning for the parcel herein described.

Thence, continuing South - 88 Degrees - 34 minutes - 42 seconds - West, 321.78 feet to a point in the centerline of aforesaid County Road #545. Passing an iron pipe found at 301.77 feet. Thence, with said centerline, the following two (2) courses and distances:

1. North - 01 Degrees - 34 minutes - 28 seconds - West, 241.05 feet to a point.

2. North - 03 Degrees - 00 minutes - 28 seconds - East, 24.38 feet to a nail set.

Thence, North - 88 Degrees - 34 minutes - 42 seconds - East, 320.28 feet to an iron pin set.

Thence, South - 01 Degrees - 28 minutes - 37 seconds - East, 265.35 feet to the place of beginning and containing 1.961 acres more or less and being a part of lands as described in Deed Volume 862, page 295 of the County Records.

Beginning at a nail set on the East line of said Quarter Township 2 at the intersection of Co. Rd. #545, also known as Vickers Hill Road.

Thence, with the centerline of said road, the following two (2) courses and distances:

1. South - 60 Degrees - 48 minutes - 14 seconds - West, 155.95 feet to a point.
2. South - 66 Degrees - 20 minutes - 23 seconds - West, 145.36 feet to a point.
3. South - 64 Degrees - 34 minutes - 34 seconds - West, 13.50 feet to a nail set and the true place of beginning for the parcel herein described.

Thence, continuing along said County Road, the following eight (8) courses and distances:



