Thence along the west line of said Conley lands, South 02 degrees 31 minutes 35 seconds West, 199.99 feet to an iron pin set, passing an iron pin found at 99.99 feet, on a north line of Hanby Properties, LLC, (OR 2347-117);

Thence along said Hanby lands, North 87 degrees 51 minutes 18 seconds West, 352.17 feet, passing an iron pin set at 315.54 feet, to a point in the centerline of St. Rte. 586;

Thence along the centerline of St. Rte. 586, North 02 degrees 39 minutes 35 seconds East, 199.99 feet, to the principal place of beginning, containing 1.616 acres, more or less, with 0.138 acres, more or less within the right of way of St. Rte. 586, and being all of Auditor's Parcel Numbers 35-02-51-12-000 (+- 0.807 Acres), and 35-02-51-13-000 (+- 0.809 Acres).
