DEED DESCRIPTION

Situated in the State of Ohio, County of Muskingum, Township of Licking, T-2, R-9, being a part of Trustees of the One Way Fellowship Church Vol. 688 Pg. 262, being part of Quarter Twp. 2, and more particularly described as follows:

Beginning at the centerline of Black Run - Nashport Rd. (St. Rt. 586) and the Licking Twp., Jackson Twp. Line; thence along the Quarter Line South 85 Degrees 00 Minutes 00 Seconds East 1035.60 feet to a point; thence South 02 Degrees 42 Minutes 30 Seconds East 907.23 feet to an iron pin found and the place of beginning; thence South 02 Degrees 42 Minutes 30 Seconds East 309.70 feet to an iron pin found; thence North 85 Degrees 29 Minutes 00 Seconds West 341.50 feet to an iron pin set; thence North 49 Degrees 04 Minutes 34 Seconds East 431.20 feet to the place of beginning. containing 1.20 acres, more or less, subject to all legal highways and easements.

Also the following 30 foot easement for ingress & egress, along an existing gravel drive, whose centerline is described as follows:

Beginning at the centerline of Black Run - Nashport Rd. (St. Rt. 586) and the Licking Twp., Jackson Twp. Line; thence along the Quarter Line South 85 Degrees 00 Minutes 00 Seconds East 1035.60 feet to a point; thence South 02 Degrees 42 Minutes 30 Seconds East 907.23 feet to an iron pin found; thence South 02 Degrees 42 Minutes 30 Seconds East 309.70 feet to an iron pin found; thence North 85 Degrees 29 Minutes 00 Seconds West 341.50 feet to an iron pin set; thence North 49 Degrees 04 Minutes 34 Seconds East 16.66 feet to a point and the place of beginning; thence along an existing gravel drive the next 6 courses to point: North 79 Degrees 04 Minutes 04 Seconds West 59.28 feet; thence North 70 Degrees 12 Minutes 47 Seconds West 126.09 feet; thence North 85 Degrees 23 Minutes 02 Seconds West 182.48 feet; thence South 60 Degrees 28 Minutes 07 Seconds West 63.39 feet; thence South 42 Degrees 33 Minutes 58 Seconds West 54.54 feet; thence North 85 Degrees 15 Minutes 10 Seconds West 353.54 feet to a point in the centerline of St. Rt. 586.





