

## DESCRIPTION

Situated in Licking Township, Muskingum County, State of Ohio and being a part of the Second Quarter of Township 2, Range 9, United States Military Lands, more fully described as follows:

Commencing at a found iron pin marking the Southwest corner of the lands of Jeffrey and Joyce Hood whose title is recorded in Vol. 1089, Pg. 613, Muskingum County Deed Records and shown on the Vansickle Drive Road Dedication Plat as recorded in Plat Book 16, Pg. 55; thence along the North Right of Way line of Vansickle Drive the following 8 courses;

1. to the Right along the curved ROW line to a found iron pin, Curve Data being Chord Bearing and Distance - N 79° 37' 00" W 146.33 feet Radius - 547.45 feet
2. N 71° 56' 00" W 297.08 feet to a found iron pin
3. N 71° 59' 12" W 101.81 feet to a found iron pin
4. N 78° 59' 15" W 160.05 feet to a found iron pin
5. N 73° 46' 21" W 27.98 feet to a found iron pin
6. thence to the right along the curved ROW line to a found iron pin, Curve data being, Chord Bearing and Distance - N 48° 02' 31" W 30.36 feet Radius - 35.00 feet
7. N 22° 04' 06" W 8.58 feet to a found iron pin
8. thence to the left along the curved ROW line to the True Point of Beginning of the herein described tract, and marked by a set iron pin, Curve data being, Chord Bearing and Distance - N 20° 19' 42" E 30.18 feet Radius - 50.00 feet

thence to the left along the curved ROW line to a point, Curve data being, Chord Bearing and Distance N 87° 27' 32" W 100.00 feet, Radius=50.00 feet, Arc Distance=157.08 feet, Chord passes over found iron pin marking center of cul-de-sac;

thence to the left along the curved ROW line to the terminal point of the curved ROW line and marked by a found iron pin, Curve data being, Chord Bearing and Distance S 39° 49' 35" E 67.40 feet, Radius=50.00 feet, Arc distance=73.96 feet;

thence S 22° 32' 54" E along the Southerly ROW line a distance of 8.60 feet to a point marked by a found iron pin;

thence to the left along the curved ROW line to a point marked by a set iron pin, Curve data being, Chord Bearing and Distance S 33° 54' 35" E 22.12 feet, Radius=85.00 feet, Arc Distance=22.18 feet;

thence N 78° 59' 34" W along the Southerly line of subject title lands a distance of 126.15 feet to a point marked by a found 3/4 inch pipe on the Westerly line of subject title lands;

thence N 13° 57' 59" W along said Westerly line a distance of 129.43 feet to a found 3/4 inch pipe marking the Northwest corner of subject title lands;

thence N 65° 36' 08" E along the Northerly line of said lands a distance of 256.64 feet to a point marked by a found iron pin and being the Northwest corner of the lands of Richard and Cynthia Morrison whose title is recorded in Vol. 1112, Pg. 589, Muskingum County Deed Records;

thence S 29° 35' 16" E along the line common to said Morrison and subject title lands a distance of 175.75 feet to a point;

thence N 59° 06' 23" E along aforesaid common line a distance of 40.02 feet to a point marked by a found iron pin;

thence S 20° 50' 42" W a distance of 68.93 feet to a point marked by a set iron pin;

thence N 82° 15' 12" W a distance of 111.71 feet to a point;

thence S 88° 58' 21" W a distance of 23.46 feet to the True Point of Beginning.



