Situated in Licking Township, Muskingum County, Ohio, and being a part of Quarter Township Two (2), Township Two (2), Range 9 and being all of the remainder of a 191.51 acre tract now owned by Doris I. Jones as recorded in Deed Book 978, page 137 of the Muskingum County, Ohio Recorder's Office and being more particularly described as follows:

Beginning at a point in the existing centerline of State Route 146 at station 118+14.00 and on file at Division 5 Ohio State Highway Department, Newark, Ohio, and at the northwest corner of a 28.55 acre tract of land now owned by Don C. and Beth A. Flowers as recorded in Deed Book 1159, page 936 of the Muskingum County, Ohio Recorder's Office.

**Thence** with Don C. and Beth A. Flowers' west line S 28°44'38" W a distance of 255.15 feet to a 1" pipe found at a common corner for a 3.006 acre tract now owned by Tammy L. Cody as recorded in Deed Book 2115, page 763 and a 0.61 acre tract now owned by Stephen J. and Janet L. Gaswint, Trustees as recorded in Deed Book 2126, page 218 of the Muskingum County, Ohio Recorder's Office.

**Thence** with Stephen J. and Janet L. Gaswint, Trustees' northwest line the following five (5) courses:

- 1) S 73°02'56" W a distance of 62.56 feet to a 5/8" iron pin found.
- 2) N 78°42'04" W a distance of 49.13 feet to a 5/8" iron pin found.
- 3) N 67°00'11" W a distance of 49.90 feet to a 5/8" iron pin found.
- 4) A curve to the left having a radius of 69.13 feet, an arc length of 81.09 feet, being subtended by a chord of S 79°29'33" W for a distance of 76.52 feet to a 5/8" iron pin found.
- 5) S 45°46'43" W a distance of 117.60 feet to a 5/8" iron pin found at the most northeast corner of a 0.972 acre tract now owned by Stephen J. and Janet L. Gaswint, Trustees as recorded in Deed Book 2126, page 218 of the Muskingum County, Ohio Recorder's Office.

**Thence** with Stephen J. and Janet L. Gaswint, Trustees' 0.972 acre tract the following two (2) courses:

- 1) N 43°01'48" W a distance of 228.38 feet to a 5/8" iron pin found.
- 2) S 53°13'37" W a distance of 273.46 feet to a 5/8" iron pin found in the northeast line of Lot 161 of Cedar Hills Subdivision, Section 4 as recorded in Plat Book 13, page 66 of the Muskingum County, Ohio Recorder's Office.

**Thence** with the northeast line of said Cedar Hills Subdivision, Section 4, N 39°26'43" W a distance of 193.12 feet to a 1" iron pipe found at a common corner for Lot 162 of said Cedar Hills Subdivision, Section 4 and Lot 163 of Cedar Hills Subdivision, Section 4 Revised as recorded in Plat Book 15, page 84 of the Muskingum County, Ohio Recorder's Office.

**Thence** east line of said Cedar Hills Subdivision, Section 4 Revised N 27°11'51" E a distance of 414.63 feet to a 5/8" iron pin found in the east line of Lot 166 of said Cedar Hills Subdivision, Section 4 Revised, and the southwest corner of a 1.65 acre tract now owned by John Schlaegel as recorded in Deed Book 1151, page 486 of the Muskingum County, Ohio Recorder's Office.

**Thence** with John Schlaegel's south and east line the following three (3) courses:

- 1) S 54°34'54" E a distance of 292.41 feet to a 5/8" iron pin found.
- 2) N 35°24'05" E a distance of 58.06 feet to a 5/8" iron pin found.
- 3) N 24°41'45" E (passing a 5/8" iron pin found at 151.81 feet) for a total distance of 191.18 feet to the centerline of State Route 146.

**Thence** with the centerline of State Route 146 S 56°04'43" E a distance of 472.93 feet to the point of beginning **Containing 6.982 acres**, more or less, of land, of which, 0.648 acres is in

the Right-of Way of State Route 146. Subject, however, to all legal highways, easements, and restrictions of record.

Bearings are based upon the recorded bearing (N 27° 11' 51" E), being a east line of Cedar Hills Subdivision, Section 4 Revised as recorded in Plat Book 15, page 84 in the Muskingum County, Ohio Recorder's Office.

Being the result of a survey and plat dated March 21, 2010, made under the supervision of Michael L. Huston, Ohio Registered Surveyor No. 8253.




