

DESCRIPTION

Situated in Licking Township, Muskingum County, State of Ohio and being a part of the Second Quarter, Township Two, Range Nine, United States Military Lands, more fully described as follows:

Commencing for a point of reference at a found P.K. nail at the intersection of the center lines of County Road No. 8 and State Route No. 586, said point being described in the Second Parcel of a deed recorded in Vol. 804, Pg. 90, Muskingum County Deed Records; thence N 6° 22' 52" W along the center line of said County Road No. 8 a distance of 337.85 feet to a point; thence N 76° 50' 43" E a distance of 97.52 feet to a point on the East line of the Ohio Canal Lands and being the Southwest corner of the lands of James E. Lacy whose title is recorded in Vol. 423, Pg. 234, and Vol. 976, Pg. 146, Muskingum County Deed Records; thence N 4° 48' 28" W along the East line of the Ohio Canal Lands a distance of 470.03 feet to a point marked by a set iron pin and being the True Point of Beginning of the herein described tract; thence continuing N 4° 48' 28" W along the East line of said Ohio Canal Lands a distance of 373.57 feet to a point marked by a reset iron pin, original iron pin disturbed; thence N 3° 38' 58" W along the East line of said Ohio Canal Lands a distance of 325.11 feet to a point marked by a found iron pin and being the Northwest corner of aforesaid Lacy lands; thence N 88° 36' 58" E along the North line of said Lacy lands a distance of 201.91 feet to a point marked by a found iron pin and being the Northeast corner of said Lacy lands; thence S 2° 01' 33" E along the East line of said Lacy lands a distance of 691.00 feet to a point marked by a set iron pin; thence S 86° 22' 56" W a distance of 174.62 feet to the True Point of Beginning. Containing 3.029 acres, more or less.
