COMMENCING AT AN EXISTING STONE ON THE EAST LINE OF QUARTER TOWNSHIP 2 AT THE SOUTHWEST CORNER OF LOT 20 OF ROBERTS SURVEY OF A PART OF THE FIRST QUARTER OF TOWNSHIP 2, RANGE 9; THENCE SOUTH 00 DEGREES 08 MINUTES 34 SECONDS WEST 864.34 FEET ALONG THE EAST LINE OF SAID QUARTER TOWNSHIP 2 TO A POINT IN THE CENTER OF COUNTY ROAD 545 (VICKERS HILL ROAD); THENCE SOUTH 64 DEGREES 41 MINUTES 48 SECONDS WEST 451.57 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) IN THE CENTER OF SAID ROAD; AT THE SOUTHEAST CORNER OF A 40.45 MORE OR LESS ACRE TRACT CONVEYED TO E. H. EVERETT MC COWAN AND SARAH B. MC COWAN BY DEED RECORDED IN VOLUME 894, PAGE 253 OF THE MUSKINGUM COUNTY DEED RECORDS; THENCE WITH THE SOUTH LINE OF SAID MC COWAN TRACT AND THE CENTER OF SAID ROAD THE NEXT TWO COURSES AND DISTANCES:

- 1) SOUTH 55 DEGREES 43 MINUTES 28 SECONDS WEST 71.09 FEET TO A POINT;

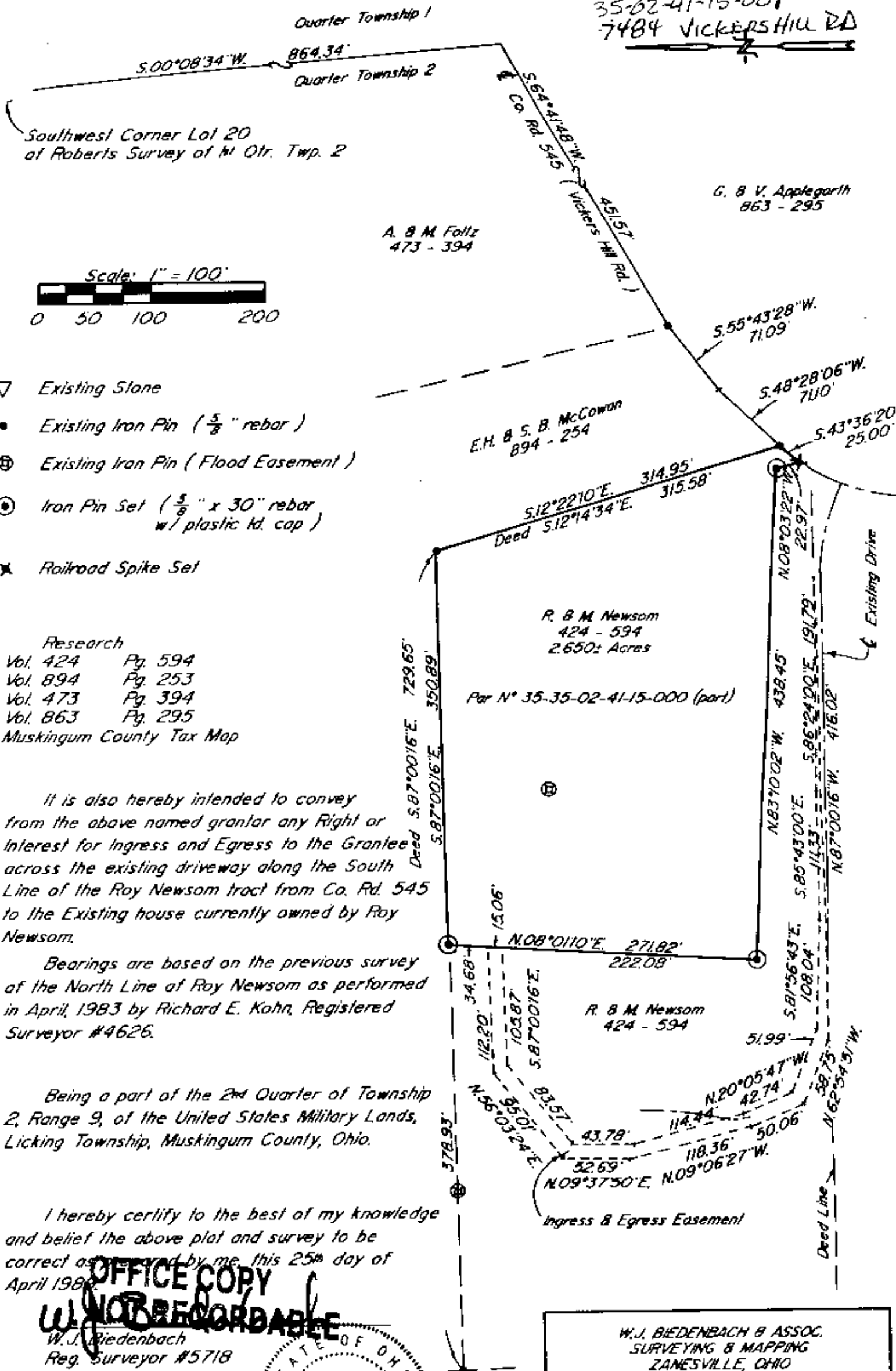
