

DESCRIPTION

Situated in Licking Township, Muskingum County, State of Ohio and being a part of the Second Quarter of Township 2, Range 9, United States Military Lands, more fully described as follows:

Commencing at a found iron pin marking the Southwest corner of the lands of Jeffery and Joyce Hood whose title is recorded in Vol. 1089, Pg. 613, Muskingum County Deed Records and shown on the Vansickle Drive Road Dedication Plat as recorded in Plat Book 16, Pg. 55; thence to the right along the curved North row line of said Vansickle Drive to a found iron pin, Curve Data being,
Chord Bearing and Distance - N 79° 37' 00" W 146.33 feet
Radius - 547.45 feet

thence N 71° 56' 00" W along the North ROW line of Vansickle Drive a distance of 297.08 feet to a point marked by a found iron pin and being the True Point of Beginning of the herein described tract; thence continuing along the North ROW line of Vansickle Drive the following 6 courses,

8. thence to the left along the curved ROW line to the True Point of Beginning of the herein described Ingress and Egress Easement, Curve Data being,
Chord Bearing and Distance - N 20° 19' 42" E 30.18 feet
Radius - 50.00 feet

thence to the left along the curved ROW line to a point,
Curve Data being,
Chord Bearing and Distance - N 8° 53' 22" W 20.19 feet
to a point
Radius - 50.00 feet
thence N 88° 58' 21" E 27.81 feet to a point;
