

Tract One
+ - 91.65 Acre Split of 10999 Newark Road LLC Lands

Situated in the State of Ohio, County of Muskingum, Township of Licking, and being part of Quarter Township 2, Township 2, Range 9, United States Military Lands, and being part of the lands presently owned by 10999 Newark Road LLC, as per Official Record 2168, Page 453, and being more particularly described as follows:

Beginning for reference and the principal place of beginning at a monument found on the right of way of State Route 146, and the Licking/Muskingum County line, and being ninety five feet left of centerline station 148+40.30 as depicted on Sheet 44 of 45 of LIC/MUS-16-28.47/0.00 Right of Way Plans, and the Location Plan Recorded in Plat Book 12, Page 8, of the Muskingum County Records;

Thence along the county line, and the east line of lands presently owned by Wayne Graham, (Instr. No. 200804220009121), North 02 degrees 14 minutes 04 seconds East, 664.67 feet to an iron pin found on the southeast corner of lands presently owned by 10999 Newark Road LLC, (Instr. No. 200804160008656);

Thence continuing along the county line and said east line of 10999 Newark Road LLC lands, North 02 degrees 19 minutes 50 seconds East, 883.25 feet to a point from which an iron pin set bears South 34 degrees 31 minutes 26 seconds West, 36.98 feet;

Beginning for reference at a monument found on the right of way of State Route 146, and the Licking\Muskingum County line, and being ninety five feet left of centerline station 148+40.30 as depicted on Sheet 44 of 45 of LIC/MUS-16-28.47/0.00 Right of Way Plans, and the Location Plan Recorded in Plat Book 9, Pages 82, 83, and 84 of the Licking County Records;

- 4.) South 12 degrees 31 minutes 33 seconds East, 130.29 feet to a point in lands presently owned by 10999 Newark Road LLC,(OR 2168-453), passing the county line at 76.85 feet;

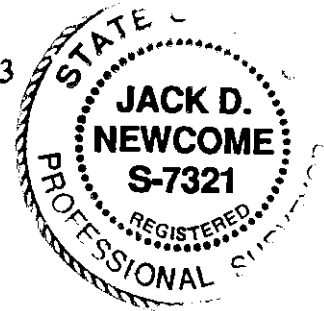

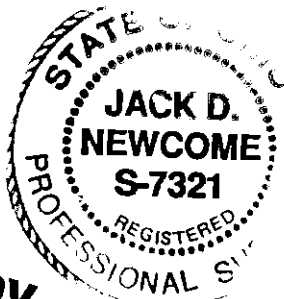
