BEING A PART OF THE SOUTHEAST CORNER OF LOT NUMBER 20 OF THE ROBERTS SURVEY IN LICKING TOWNSHIP, SITUATED IN THE SOUTH HALF OF QUARTER TOWNSHIP 1, OF TOWNSHIP 2, RANGE 9, LICKING TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN SET MARKING SOUTHEAST CORNER OF SAID LOT NUMBER 20; THENCE SOUTH 85 DEGREES 45 MINUTES 57 SECONDS WEST 333.73 ALONG THE SOUTH LINE OF SAID LOT NUMBER 20 TO A POINT IN THE CENTER OF COUNTY ROAD 545 (VICKERS HILL ROAD), SAID POINT BEING NORTH 85 DEGREES 45 MINUTES 57 SECONDS EAST 1339.30 FEET FROM THE SOUTHWEST CORNER OF SAID LOT NUMBER 20, SAID POINT ALSO BEING NORTH 85 DEGREES 45 MINUTES 57 SECONDS EAST 39.30 FEET FROM AN EXISTING 1/2 INCH REBAR, PASSING AN IRON PIN SET AT 293.73 FEET; THENCE NORTH 49 DEGREES 08 MINUTES 47 SECONDS EAST 46.37 FEET ALONG THE CENTERLINE OF SAID COUNTY ROAD 545 TO A POINT; THENCE WITH A CURVE TO THE RIGHT HAVING A RADIUS OF 1098.74 FEET (CHORD BEARING NORTH 55 DEGREES 28 MINUTES 51 EAST 247.01 FEET TO A POINT, THENCE NORTH 62 DEGREES 03 MINUTES 16 SECONDS EAST 92.24 FEET ALONG THE CENTERLINE OF SAID COUNTY ROAD 545 TO A POINT ON THE EAST LINE OF SAID LOT NUMBER 20, SAID POINT BEING SOUTH 03 DEGREES 51 MINUTES 36 SECONDS EAST 29.41 FEET FROM AN EXISTING 1/2 INCH REBAR; THENCE SOUTH 03 DEGREES 51 MINUTES 36 SECONDS EAST 189.32 FEET ALONG THE EAST LINE OF SAID LOT NUMBER 20 TO THE PLACE OF BEGINNING, PASSING AN IRON PIN SET AT 25.00 FEET.
