Thence along the south line of said Crozier lands, South 89 degrees 08 minutes 26 seconds East, 446.78 feet to a stone found on the northwest corner of lands presently owned by M. S. Conley(Spiker), (OR 1920-466);

Thence along the west line of said Conley lands, and the west line of the Southeast Quarter, South 00 degrees 00 minutes 00 seconds East, 646.46 feet to an iron pin found on the northwest corner of lands presently owned by the Reliable Investment Company(OR 1672-590);

Thence along the west line of said Reliable Investment Company lands, and the west line of the Southeast Quarter, South 00 degrees 00 minutes 00 seconds East, 723.12 feet to the principal place of beginning, passing an iron pin found at 703.62 feet, containing 12.43 acres more or less;
