Situated in Lot #23, Quarter Township #1, T-2-N, R-9-W, U.S.M.L., Licking Township, Muskingum County, Ohio. Being part of the lands of Paul and Nancy Crozier as conveyed in Deed Book 1098 page 153 of the Muskingum County deed records and being described as follows:

Commencing at an iron pin found marking the Southwest corner of lot #23; thence, N.89°51'40"E. a distance of 967.08 feet along the south line of lot #23 to a found stone; thence, S.89°44'27"E. a distance of 1,140.26 feet along said south line of said lot to a point in County Road #56 (Shannon Valley Road); thence, N.37°15'56"E. a distance of 62.61 feet along the east line of the lands of Paul and Nancy Crozier (198/153) to a point in the right of way of said county road, BEING THE POINT OF BEGINNING;

thence, N.89°44'27"W. a distance of 323.87 feet through said Crozier lands to a set iron pipe, passing a set iron pipe at 50.00 feet;

thence, N.00°15'33"E. a distance of 150.00 feet through said Crozier lands to a set iron pipe;

thence, S.89°44'27"E. a distance of 436.93 feet through said Crozier lands to a point in the right of way of County Road #56 (Shannon Valley Road) passing a set iron pipe at 386.93 feet;

thence, S.37°15'56"W. a distance of 187.84 feet through said road right of way to the point of beginning.

The above described parcel contains 1.310 acres, more or less, and is subject to all legal easements and right of ways. All set iron pipes are 3/4" x 30" pipes with plastic I.D. caps. All set rebars are 5/8" x 30" rebars. North is based on an assumed meridian.

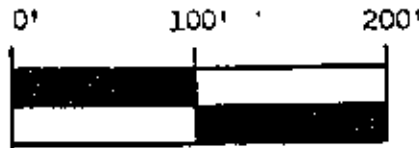

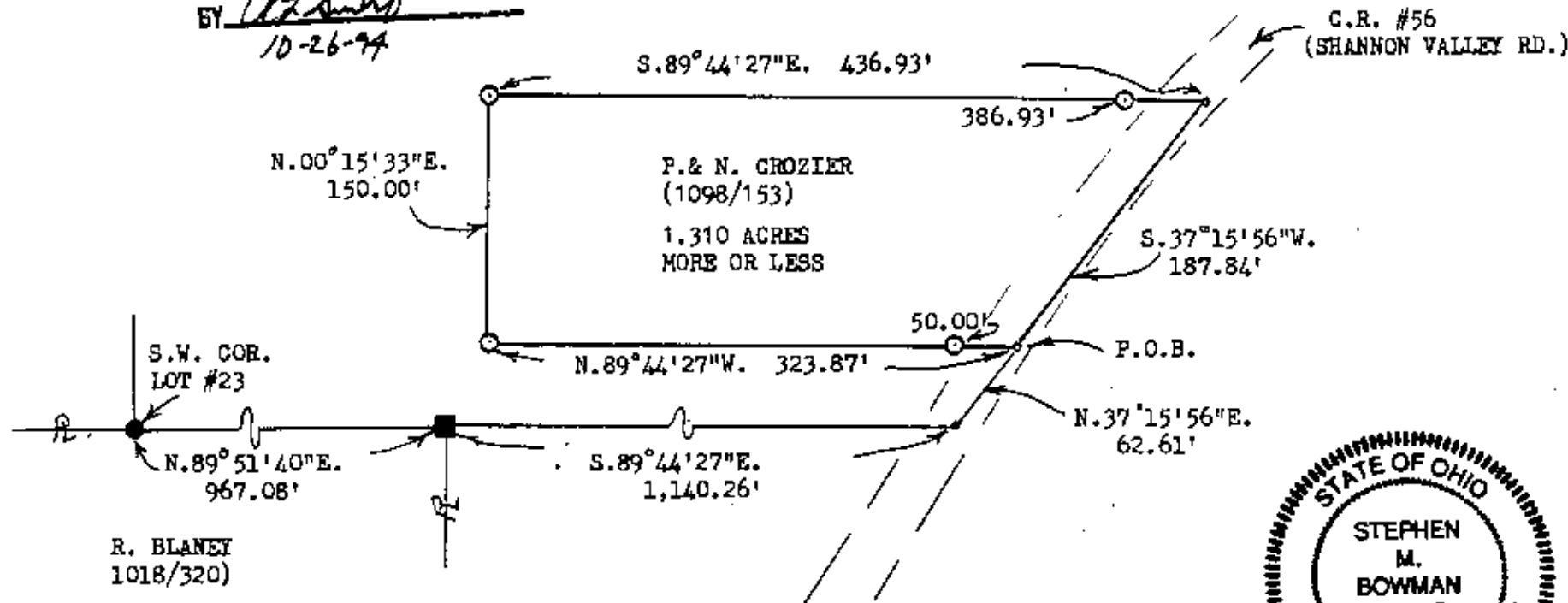
