

## Re-Survey of Benjamin T. Moore Jr. Lands

Situated in the State of Ohio, County of Muskingum, Township of Licking, and being part of Quarter Township 1, Township 2, Range 9, United States Military Lands, and being all the lands presently owned by Benjamin T. Moore Jr. as per Deed Record 802, Page 45, and being more particularly described as follows:

Beginning for reference at an iron pin found at the Northeast Corner of Lot 4, of a subdivision of Thomas Will's land, as depicted in Plat Book A-O, Page 114;

Thence North 87 degrees 09 minutes 49 seconds West, 127.16 feet to an iron pin found on the southeast corner of lands formerly owned by Rebecca and Benjamin T. Moore Jr. (DR 813-314);

Thence along the former east line of said Moore lands, North 02 degrees 06 minutes 50 seconds West, 1015.55 feet to a point in Prior Road, (Twp. Rd. 406), and the principal place of beginning;

Thence along the lines of Rebecca and Benjamin T. Moore Jr., (DR 813-314), lands the following three courses:

- 1.) South 63 degrees 18 minutes 33 seconds West, 409.70 feet to an axle found, passing an iron pipe found at 19.68 feet;
- 2.) North 03 degrees 05 minutes 44 seconds East, 367.44 feet to a point, passing an axle found at 359.06 feet;
- 3.) North 63 degrees 15 minutes 05 seconds East, 225.50 feet to an iron pin found on the southwest corner of lands presently owned by Shana B. Moore, (OR 2068-691);

Thence along the south line of said Shana Moore lands, North 63 degrees 15 minutes 20 seconds East, 177.23 feet to a point on the west line of lands presently owned by Mark K. and Michelle M. Neal, (OR 2611-718, and Lynette Mealey, (OR 2599-241), passing an iron pin found at 175.71 feet;

Thence along the west line of said Neal and Mealey lands, South 02 degrees 06 minutes 50 seconds West, 364.37 feet to the principal place of beginning, containing 2.98 acres, more or less, and being all of Auditor's Parcel Number 35-10-71-24-000.

Subject to all legal recorded easements and right of ways.

Iron pins set are 5/8 inch rebars, 30 inches long, with plastic identification caps.

Bearings are based on the Ohio State Plane Coordinate System, NAD 83, South Zone, Grid North, as per GPS observations.
