Beginning for reference at an iron pin found at the
Northeast corner of Lot 4, of Subdivision of Thomas Wills Land,
as depicted in Plat Book A-O, page 114, of the Muskingum County
Records. Thence along the north line of said Lot 4 North 90
degrees 00 minutes 00 seconds West, 127.16 to an iron pin set at
the southeast corner of lands presently owned by Benjamin T. Jr.
and Rebecca Moore (DR 813-314), and the principal place of
beginning; thence continuing along said north line of Lot 4, and
the south line of said Moore lands North 90 degrees 00 minutes 00
seconds West, 378.00 feet to a point in Prior Road (Twp. Rd. 406);
thence leaving said road and through said Moore lands the
following two courses: 1.) North 00 degrees 43 minutes 00 seconds
West, 370.00 feet to an iron pin set, passing an iron pin set at
21.00 feet; 2.) North 90 degrees 00 minutes 00 seconds East,
378.00 feet to an iron pin set on the west line of lands
presently owned by L. A. Prior et. al. (DR 1157-577); thence along
said west line South 00 degrees 43 minutes 00 seconds East,
370.00 feet, to the principal place of beginning, containing 3.21
acres more or less.

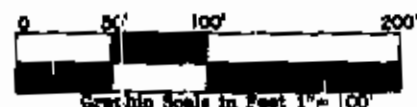
