Bishop(DR 314-290), North 88 degrees 22 minutes 00 seconds West, 413.25 feet, to an iron pin set at the southwest corner of tract nine and the southeast corner of tract eight; thence through said 48.22 acre tract, North 17 degrees 34 minutes 53 seconds East, 574.83 feet to an iron pin set on the south line of a proposed right of way, at the northwest corner of said tract 9; thence across said right of way North 53 degrees 20 minutes 33 seconds East 53.03 feet to an iron pin set on the north side of said right of way, at an angle point in said right of way, and the principal place of beginning; thence along said right of way the following three courses: 1. North 56 degrees 06 minutes 27 seconds West, 253.44 feet to an iron pin set, 2.) on a curve to the right having a central angle of 52 degrees 19 minutes 48 seconds, a radius of 30.00 feet, a length of 27.40 feet, and a chord which bears North 29 degrees 56 minutes 33 seconds West, 26.46 feet to an iron pin set, 3.) On a curve to the left having a central angle of 8 degrees 02 minutes 28 seconds, a radius of 60.00 feet, a length of 8.42 feet, and a chord which bears North 07 degrees 47 minutes 53 seconds West, 8.41 feet to an iron pin set; thence leaving said right of way North 69 degrees 37 minutes 56 seconds East, 879.03 feet to a point in the centerline of County Road 408(Pleasant Valley Road), passing an iron pin set at 839.25 feet on the right of way of said road; thence along said centerline South 48 degrees 44 minutes 30 seconds East, 292.12 feet to a point; thence leaving said centerline South 69 degrees 48 minutes 59 seconds West, 851.10 feet to an iron pin set on said north right of way, passing an iron pin set at 43.50 feet; thence North 68 degrees 52 minutes 34 seconds West, 21.55 feet to the principal place of beginning, containing 5.15 acres more or less, of which 0.25 acres more or less are in the right of way of Co.
