East Side Split of Patricia Moore Property

Thence along said south line South 88 degrees 37 minutes 32 seconds East, 159.68 feet to an iron pin found on the west line of lands presently owned by R. and R. McDonald(DR 1080-341);

Thence along said west line, South 01 degrees 18 minutes 42 seconds West, 169.27 feet to an iron pin found on the northwest corner of lands presently owned by Clay City Beverage Inc.(DR 976-317);

Thence along said west line, South 01 degrees 18 minutes 42 seconds West, 1326.79 feet to an iron pin found on the south west corner of said Clay City lands, and the township line;

Thence along the south line of said Clay City lands and the Lownship line, South 88 degrees 51 minutes 44 seconds East, 1444.02 feet to a point in a 36 inch diameter oak tree, being the northwest corner of lands presently owned by D. R. McNeal (DR 1062-547), from which a chiseled cross found on a large flat stone, bears North 06 degrees 39 minutes 49 seconds East, 3.42 feet, as a reference;

- 3.) North 17 degrees 24 minutes 12 seconds West 216.99 feet to a point;
- 4.) Along a non-tangent curve to the right with a radius 980.75 feet, an arc length of 227.44 feet, and a chord which bears North 14 degrees II minutes 23 seconds West, 227.03 feet to the principal place of beginning, containing 32.69 acres, more or less, being 6.54 acres in part of Lot No. 6 of Craig's Subdivision in the South Half of Quarter Township 3, Licking Township, Township 2, Range 9, and 26.15 acres in part of the Northeast Quarter of Section 5, Hopewell Township, Township 1, Range 9, United States Military Lands.
