1. SUBJECT PARCEL BEING SITUATED IN THE TOWNSHIP OF LICKING, COUNTY OF MUSKINGUM, AND STATE OF OHIO, AND BEING PART OF QUARTER TOWNSHIP 4, TOWNSHIP RANGE 9, IN THE UNITED STATES MILITARY LANDS, AND BEING ALL OF PARCEL NUMBERS 35-46-01-04-000, 35-46-01-04-011, AND 35-46-01-04-012.
2. THE BASIS OF BEARING, IS DERIVED FROM ODOT VRS NETWORK, OHIO SOUTH NAVD88(2011), BEING THE CENTERLINE OF NEWARK ROAD (S.R.146), NORTH 55° 30' 06" WEST.
3. BY SCALED MAP LOCATION AND GRAPHIC PLOTTING ONLY, THE SUBJECT PROPERTY APPEARS TO LIE ENTIRELY IN ZONE X UNSHADED (AREAS DETERMINED TO BE OUTSIDE THE 0.2% ANNUAL CHANCE FLOODPLAIN) ACCORDING TO THE FLOOD INSURANCE RATE MAP, COMMUNITY PANEL NO. 39119C0165G, PANEL 165 OF 500, EFFECTIVE DATE JULY 6, 2010.
