Situated in the County of Muskingum, in the State of Ohio, and in the Township of Licking, and bounded and described as follows:

Being a part of the Fourth Quarter of Township 2, Range 9, bounded and described as follows:

Commencing at an iron pin at the northwest corner of Lot 14 of Dillon Hills Subdivision as shown on a plat thereof recorded in Plat Book 10, page 33 of the Records of Muskingum County, Ohio; thence following along the East line of a proposed road or street on a curve to the left having a radius of 243.7 feet the long chord of which bears north 5 degrees 18 minutes west, a distance of 76.14 feet; thence continuing along the east line of said proposed road north 14 degrees 15 minutes west 137.86 feet to a point; thence continuing along the east line of said road on a curve to the right having a radius of 286.75 feet, the long chord of which bears north 2 degrees 15 minutes east a distance of 166 feet to an iron pin; thence continuing along the said east line of the road north 18 degrees 55 minutes east 225.63 feet to an iron pin; thence crossing said proposed road north 71 degrees 05 minutes west 40 feet to an iron pin on the west side of said proposed road; thence along the west side of said road on a curve to the left having a radius of 535.23 feet a distance of 133.75 feet, (the chord of which bears north 11 degrees 47 minutes east) to an iron pin and the true place of beginning of the premises herein intended to be conveyed; thence north 81 degrees 39 minutes west 200 feet to an iron pin; thence north 6 degrees 43 minutes west 144 feet to an iron pin; thence north 85 degrees 52 minutes east 200 feet to an iron pin on the west line of the aforesaid proposed road; thence along the west line of said road south 9 degrees 45 minutes east 54 feet to an iron pin; thence continuing along the west line of said road on a curve to the right having a radius of 535.23 feet a distance of 133.75 feet (chord of which bears south 2 degrees 37 minutes east) to the true place of beginning, containing seventy-six hundredths (0.76) of an acre, more or less.

There is also hereby conveyed to the grantees herein an easement for ingress and egress 40 feet wide and extending in a southerly direction to its intersection with Layman Drive in Dillon Hills No. 1.
