- #1- THENCE North 87 degrees 54 minutes 30 seconds West 1321.63 feet along the common line for Sections 27 and 34 and through said Ohio Franklin Realty, LLC property to an iron pin (found) at the Southeast corner of the Jeffrey S Knepp and Aaron Gregory property recorded in Official Record Volume 2289, Page 887, passing the centerline of Oak Grove Road (County Road 43) at 483.95 feet;
