

**DESCRIPTION OF SURVEY FOR OHIO FRANKLIN REALTY, LLC

- #26- THENCE with a curve to the right having, a chord bearing South 01 degrees 10 minutes 36 seconds East 164.52 feet, a radius of 823.35 feet, and arc length of 164.79 feet continuing along said road and properties to an unmarked point;**
- #27- THENCE with a curve to the left having, a chord bearing South 14 degrees 45 minutes 23 seconds East 169.99 feet, a radius of 257.00 feet, and arc length of 173.25 feet continuing along said road and properties to an unmarked point on the common line for Sections 27 and 28 of said Township and Range;**
- #28- THENCE South 02 degrees 07 minutes 58 seconds West 1314.48 feet** leaving said road, along said Section line and common line for said Ohio Franklin Realty, LLC property and for the Clarence Kirkbride Jr. property recorded in Deed Book Volume 1007, Page 50 to the calculated Northeast corner of the Southeast Quarter of Section 28, passing an iron pin (set) at 58.87 feet, and iron pin (set) at 852.71 feet being the Southwest corner of said Kirkbride property and the place where this call goes through said Ohio Franklin Realty, LLC property;
