Real estate situated in the Township of Monroe, County of Muskingum, and in the State of Ohio, and bounded and described as follows:

Being a part of the West half of the Northwest quarter of Section six, Township 3N., Range 5W., United States Military Lands and being more particularly described as follows:

Beginning at an iron pipe found at the Southwest corner of the said West half of the Northwest quarter of Section six; said iron pipe found being the True Place of Beginning for the tract of land herein described; thence, with the Adams and Monroe Township line, N.1°26'52"E. a distance of 2,666.64 feet to an iron pipe set, passing an iron pipe found at 801.87 feet;

thence, with the North line of said Section six, S.88°04'00"E. a distance of 946.72 feet to an iron pipe set;

thence, with the Muskingum Watershed Conservancy property lines (D.B.650, Pg.233) the following two courses:

1. thence, S.14°53'00"E. a distance of 248.59 feet to an iron pipe set;
2. thence, N.53°44'30"E. a distance of 325.02 feet to an iron pipe set;

thence, with the East line of the said West half of the Northwest Quarter of Section six, S.1°40'00"W. a distance of 2,623.30 feet to an iron pipe found;

thence, with the South line of the said West half of the Northwest Quarter of Section six, N.88°21'03"W. a distance of 1,263.72 feet to the True Place of Beginning, containing 76.578 acres, more or less, including all public road right of way and subject to all easements of record.


