Description for Opal Wilson in Monroe Township, Muskingum County, Ohio.

Being a tract of land in the Southeast Quarter of Section 7, Range 5W, Township 3N, Montoe Township, Muskingum County, State of Ohio, and being further described as follows;

Note: North and tie-in taken from a survey by G.A. Stewart, 9-25-1985. Research Data: Deeds, surveys and plats of record.

Beginning at an axle recovered at the Northwest corner of the lands of Larry Confer (O.R. 1151/436) and on the South line of the lands of Charles & Karen Young (O.R. 1858/502), said axle being located from a point at the Northwest corner of the said Southeast Quarter of Section 7 by the following six (6) courses;

- 1. with the North line of the said Southeast Quarter, South 86 degrees 57' 28" East, a distance of seventy-two and fifteen hundredths (72.15) feet to a recovered 3/4" rebar with aluminum cap;
- continuing with the said North line of the Southeast Quarter and continuing South 86 degrees 57' 28" East, a distance of twenty-eight and sixty-three hundredths (28.63) feet to a point on the centerline of State Route 83;
- 3. with the said centerline of State Route 83, South 25 degrees 18' 11" East, a distance of eighty-two and forty-four hundredths (82.44) feet to a point;
- 4. continuing with the said centerline of State Route 83, South 24 degrees 26' 46" East, a distance of two hundred ninety-two and forty-four hundredths (292.44) feet to a point;
- 5. continuing with the said centerline of State Route 83, South 25 degrees 50° 22° East, a distance of one hundred forty-one and forty hundredths (141.40) feet to a point at the Southeast corner of the said lands of Charles & Karen Young;
- 6. with the said South line of the said lands of Charles & Karen Young, South 55 degrees 41' 24" West, a distance of thirty-three and fifteen hundredths (33.15) feet to the said beginning point;

thence, with the said lands of Larry Confer the following four (4) courses;

- 1. South 27 degrees 52' 51" East, a distance of one hundred fifty-seven and thirty-three hundredths (157.33) feet to a recovered 1 1/2" pipe;
- 2. South 37 degrees 31' 34" East, a distance of one hundred seventy-four and twelve hundredths (174.12) feet to a recovered axle (14" deep);
- 3. South 44 degrees 06' 57" West, a distance of two hundred fifty-seven and eleven hundredths (257.11) feet to a set 5/8" x 30" rebar with plastic cap;
- 4. continuing South 44 degrees 06' 57" West, a distance of ten and no hundredths (10.00) feet to a point in a creek and on the East line of the lands of Anthony & Lisa Lombardo (O.R. 1682/134);

thence, with the said East line of the lands of Anthony & Lisa Lombardo, North 18 degrees 50' 11" West, a distance of three hundred ninety-eight and five hundredths (398.05) feet to an axle recovered on the said South line of the lands of Charles & Karen Young;

thence, with the said South line of the lands of Charles & Karen Young, North 55 degrees 38' 10" East, a distance of one hundred sixty-three and thirty-three hundredths (163.33) feet to the point of beginning;

The above described tract contains one and six hundred fifty-three thousandths (1.653) acres, more or less, as surveyed by Bruce D. Eckelberry, Registered Professional Surveyor No. 7103, October 29, 2007.
