feet to a point in the center of a small ravine passing through an iron pin  
at 32.00 feet; thence after said run the following courses and distances  
to each 10 degrees 13 minutes 17 seconds west 96.53 feet  
a north 14 degrees 10 minutes 30 seconds east 164.66 feet  
south 53 degrees 14 minutes 49 seconds east 140.86 feet  
south 53 degrees 01 minutes 16 seconds east 120.83 feet  
a north 63 degrees 15 minutes 15 seconds east 129.81 feet  
north 53 degrees 19 minutes 10 seconds east 136.92 feet  
; south 26 degrees 01 minutes 19 seconds east 102.93 feet to a point;  
thence leaving said run north 89 degrees 43 minutes 10 seconds east 205.  
feet to a point in the corner of Co. Rd. No. 15 (Burke Road); thence  
with the center of said road south 41 degrees 23 minutes 53 seconds east  
26.34 feet to spike; thence leaving said road south 89 degrees 43 minutes  
10 seconds west 2290.39 feet to a iron pin on the west line of section  
8; thence with said line north 66.89 feet to the place of beginning  
containing 24.44 acres more or less.
