

Military Lot 27;

Thence along the west line of said Lot, and the east lines of lands presently owned by said Bonifant, Taylor Swope, (OR 2701-748), and David L. and Sara E. Klein, (DR 1071-76, and DR 1135-561), North 02 degrees 03 minutes 46 seconds East, 1682.97 feet to a stone found on the northwest corner of said Lot, passing iron pins found at 84.04 feet, 173.96 feet and 1147.74 feet;

Thence along the west line of Military Lot 26, and the east line of lands presently owned by David L. and Sara E. Klein, (DR 1071-76), the following two courses:

- 1.) North 01 degrees 17 minutes 54 seconds East, 1567.80 feet to a point on the lot corner between Lot 39, and Lot 40;
- 2.) North 02 degrees 59 minutes 28 seconds East, 154.44 feet to a stone found on the southeast corner of lands presently owned by Robert B. and Amy D. McCort, (OR 1833-326), from which an iron pin found bears North 17 degrees 38 minutes 21 seconds East, 2.38 feet;

Thence along the west line of said Lot, and the east line of said McCort lands, North 02 degrees 59 minutes 28 seconds East, 1691.47 feet to a stone found on the northwest corner of said Lot, and the southwest corner of lands presently owned by Dante D. and Velvet L. Mella, (OR 2402-543);

Thence along the north line of said Lot, South 87 degrees 52 minutes 52 seconds East, 1198.82 feet to an iron pin found on the southeast corner of Mella lands;

Thence leaving the Lot line, and through Section 15, and along the east line of said Mella lands, North 01 degrees 55 minutes 56 seconds East, 660.49 feet to an iron pin found on the southwest corner of lands also presently owned by Dante D. and Velvet L. Mella, (OR 2545-25);

Thence along the south line of said Mella lands, South 87 degrees 57 minutes 47 seconds East, 1318.43 feet to an iron pin found on the west line of lands presently owned by Christopher T. and Julie A. Yoder, (OR 1874-337);

Thence along the west line of said Yoder lands, South 01 degrees 53 minutes 30 seconds West, 661.31 feet to an iron pin found on the north line of Military Lot 25;

Thence along the north line of said Lot, and the south line of said Yoder lands, South 87 degrees 55 minutes 47 seconds East, 116.51 feet to the principal place of beginning, containing 520.09 acres, more or less, and being all of Auditors Parcel Numbers, 42-40-15-02-000, (+- 20.01 Ac.), 42-40-03-01-000, (+- 53.49 Ac.), 42-40-03-02-000, (+- 53.49 Ac.), 42-40-03-06-000, (+- 102.08 Ac.), 42-40-03-07-000, (+- 100.36 Ac.), 42-40-03-14-000, (+- 96.09 Ac.), and 42-50-03-28-000, (+- 94.57 Ac.).
