Commencing at a one inch rebar set at the southeast corner of Military Lot #38, thence on the west line of Military Lot #38, N 01° 19' 58" E, a distance of 74.72 feet to an iron pin set, the BEGINNING, thence on the west line of Military Lot #38, N 01° 19' 58" E, a distance of 488.74 feet to an iron pin set, thence N 78° 55' 22" E, a distance of 365.03 feet to a railroad spike set in the center of Bell Road, (having passed through an iron pin set at 345.03 feet,) thence S 33° 29' 02" W, a distance of 669.93 feet to the beginning and containing 2.000 acres more or less, and being a part of the property conveyed in the First Parcel, volume 478, page 376 of the deed records of Muskingum County, Ohio.

Commencing at a one inch rebar set at the southwest corner of Military Lot #38, thence on the west line of Military Lot #38, N 01° 19' 58" E, a distance of 563.46 feet to an iron pin set, the BEGINNING, thence on the west line of Military Lot #38, N 01° 19' 58" E, a distance of 132.06 feet to a railroad spike set in the center of Bell Road, (having passed through an iron pin set at 112.06 feet), thence with the center of Bell Road the next eight (8) calls:

1. S 69° 28' 42" E, a distance of 69.07 feet to a railroad spike set.
2. S 78° 01' 42" E, a distance of 41.62 feet to a railroad spike set.
3. S 89° 22' 54" E, a distance of 34.41 feet to a railroad spike set.
4. N 84° 38' 23" E, a distance of 87.93 feet to a railroad spike set.
5. N 89° 34' 05" E, a distance of 43.54 feet to a railroad spike set.
6. S 78° 15' 10" E, a distance of 32.65 feet to a railroad spike set.
7. S 46° 29' 10" E, a distance of 28.64 feet to a railroad spike set.

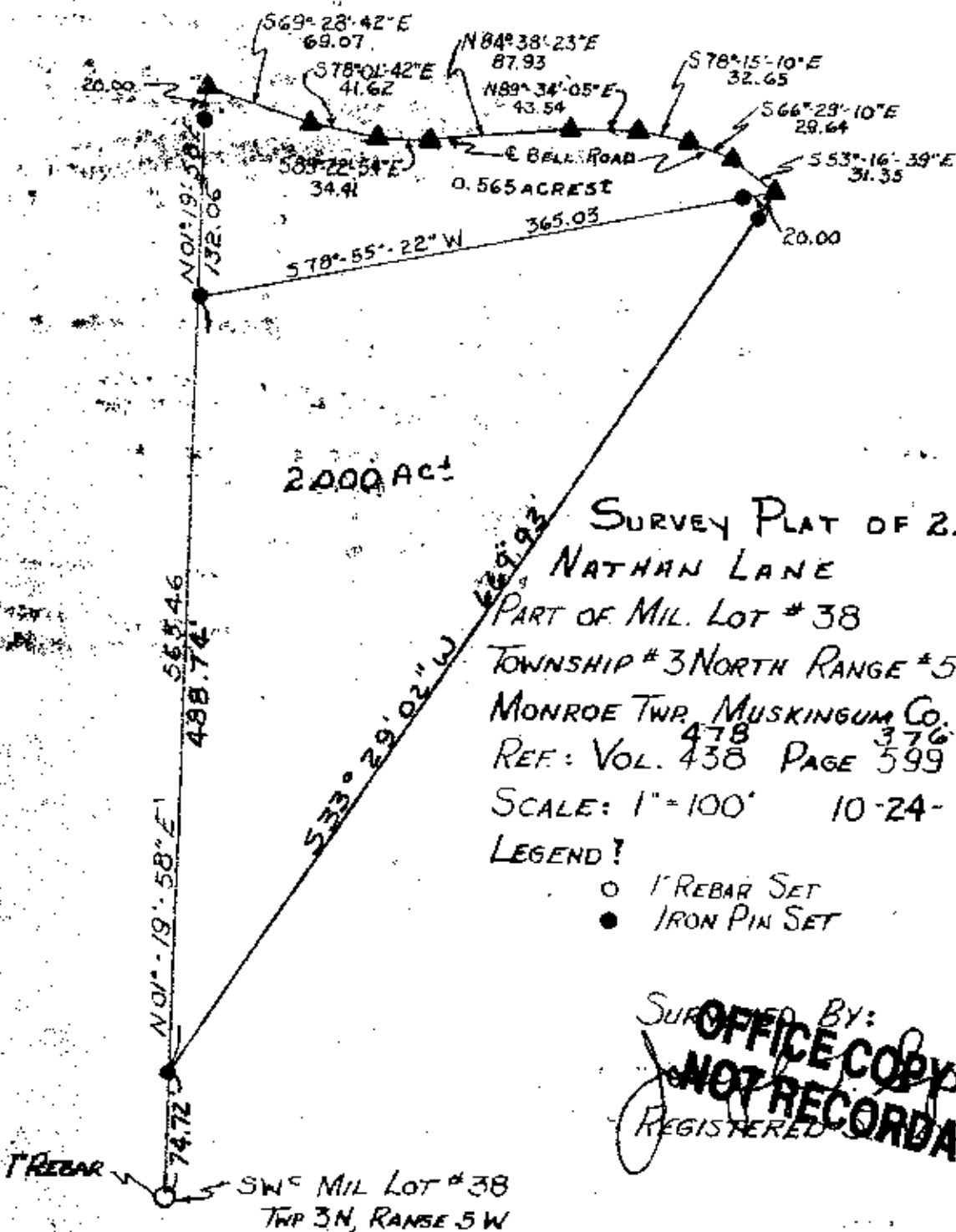
