Being 12.730 acres, more or less, (12.112 acres in Lot 37, part of parcel 42-40-03-12), (0.618 acres in Lot 38, part of parcel 42-40-03-10-), in the third quarter of township 3 north, range 5 west, United States Military Lands, in the township of Monroe, in the county of Muskingum, in the State of Ohio, and more particularly described as follows:

Beginning at a 5/8" steel pin found at the northeast corner of Lot 37, said 5/8" steel pin found being the TRUE POINT OF BEGINNING;

thence, along the Lot line, S.02°40'27"W. 1328.76' to a point;

4. thence, N.72°27'09"W. 291.51' to a 5/8" steel pin set;
5. thence, N.17°49'02"W. 142.91' to a 5/8" steel pin set;
6. thence, N.35°36'44"W. 361.91' to a point;
7. thence, N.35°39'33"E. 33.00' to a 5/8" steel pin set;
8. thence, continuing N.35°39'33"E. 1028.59' to a 5/8" steel pin set;
9. thence, continuing N.35°39'33"E. 20.00' to a point in the centerline of McCort Road, TR 170;

thence, along the centerline of McCort Road, TR 170, S.32°24'00"E. 106.00' to a point;

thence, along the Lot line the following 2 courses:

1. thence, S.02°32'33"W. 49.95' to a 5/8" steel pin found;
2. thence, continuing S.02°32'33"W. 84.04' to the TRUE POINT OF BEGINNING, containing 12.730 acres, more or less, including public road right-of-way and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied.

Bearings are based on Deed Book 931, page 187, and are for angular calculations only. N.01°19'58"E. All 5/8" steel pins set are 30" long.
