Being 6.524 acres, more or less (part of #42-60-20-02-001) in the south half of the northeast quarter of section 20, in the fourth quarter of township 3 north, range 5 west, United States Military Lands, in the township of Monroe, in the county of Muskingum, in the State of Ohio, and more particularly described as follows:

Commencing at a stone found at the northwest corner of the south half of the northeast quarter of section 20;

thence, along the east and west eighth line the following 3 courses:

1. thence, S.89°41'38"E. 87.45' to a 5/8" steel pin set;
2. thence, continuing S.89°41'38"E. 306.50' to a 5/8" steel pin set;
3. thence, continuing S.89°41'38"E. 263.88' to a 5/8" steel pin set, said 5/8" steel pin set being the TRUE POINT OF BEGINNING;

thence, continuing along the east and west eighth line the following 2 courses:

1. thence, continuing S.89°41'38"E. 989.20' to a 5/8" steel pin found;
2. thence, continuing S.89°41'38"E. 23.33' to a point in the centerline of Granny's Knob Road, CR 17;

thence, along the centerline of Granny's Knob Road, CR 17, the following 4 courses:

1. thence, S.36°09'30"W. 318.00' to a point;
2. thence, S.48°32'00"W. 61.00' to a point;
3. thence, S.56°18'00"W. 196.00' to a point;
4. thence, along a tangent curve, concave to the northwest having the following properties: delta = 14°06'16"; radius = 662.60'; arc = 212.35'; chord = S.63°21'08"W. 211.81' to a point;

thence, through the property of Bruner Land Company, 1106/512, the following 2 courses:

1. thence, N.36°44'28"W. 23.35' to a 5/8" steel pin set;
2. thence, continuing N.36°44'28"W. 627.79' to the TRUE POINT OF BEGINNING, containing 6.524 acres, more or less, including public road right-of-way and is subject to all easements, rights-of-way, or restrictions, whether recorded or implied.





