Beginning at an iron pin found at the Northeast Corner of Lot 31; thence along the East line of Lot 31 South 03 Degrees 31 Minutes 30 Seconds West 1672.71 feet to a point in Thomas Road R/W, passing an iron pin found at 1666.29 feet; thence along the South line of Lot 31 North 85 Degrees 59 Minutes 34 Seconds West 2302.62 feet to a point in the centerline of Twp. Rd. 103, passing the centerline of Thomas Road at 20.44 feet and an iron pin set at 125.00 feet and an iron pin found at 2281.26 feet; thence along the centerline of Twp. Rd. 103 North 23 Degrees 16 Minutes 03 Seconds West 54.03 feet to a point; thence along said centerline North 27 Degrees 35 Minutes 27 Seconds West 406.00 feet to an iron pin set at the intersection of Twp. Rds. 103 & 177; thence along the centerline of Twp. Rd. 177 the next 8 courses to points: North 65 Degrees 31 Minutes 40 Seconds East 63.30 feet; thence North 45 Degrees 59 Minutes 04 Seconds East 324.90 feet; thence North 51 Degrees 13 Minutes 42 Seconds East 172.95 feet; thence North 58 Degrees 56 Minutes 19 Seconds East 103.38 feet; thence North 65 Degrees 40 Minutes 07 Seconds East 833.49 feet; thence North 58 Degrees 25 Minutes 46 Seconds East 112.50 feet; thence North 61 Degrees 41 Minutes 01 Seconds East 225.01 feet; thence North 62 Degrees 26 Minutes 31 Seconds East 473.13 feet; thence leaving said centerline along the North line of Lot 31 South 86 Degrees 06 Minutes 01 Seconds East 623.15 feet to the place of beginning, passing an iron pin found at 30.00 feet, containing 70.49 acres, more or less, subject to all legal highways and easements.


